**THE NUMBER OF ELIGIBLE VOTERS AND POLLING STATIONS (TPS)  
AT THE GENERAL ELECTION OF THE PRESIDENT AND VICE PRESIDENT IN  
2004**

**THE KPU,**

- Considering** :
- a. that to conduct the General Election of the President and Vice President in 2004, it is necessary to determine the Number of Eligible Voters amongst Indonesian Citizens and the Number of Polling Stations (TPS) at the General Election of the President and Vice President in 2004;
  - b. that the Number of Eligible Voters and the Number of TPS as referred to in letter a, shall be determined by a KPU Decree;

**To enact** :

**FIRST** : The Number of Eligible Voters amongst Indonesian Citizens (WNRI) and the Number of Polling Stations (TPS) at the 2004 General Election of President and Vice President are as stated in the Attachments to this Decree.

**SECOND** : The number WNRI and the number of TPS as referred to in FIRST, shall be used for the procurement of goods/services, transportation, communication, budgeting and technical implementation of the 2004 General Election of the President and Vice President.

**THIRD** : This Decree shall come into effect upon the date it is enacted.
