Following up the letter of KPU Chairperson Number 687.1/15/IV/2004 dated 16 April 2004 on the establishment of the Final Voters Register for the General Election of the President and Vice President and the letter of KPU Vice Chairperson Number 698/15/IV/2004 on the operational guidelines for voter registration for the General Election of the President and Vice President, we inform you of the following matters:

1. Letter of KPU Chairperson Number 687.1/15/IV/004 dated 16 April 2004 in point 11, temporarily could not be enacted due to the time constraint to conduct the General Election of President and Vice President.
2. For the General Election of President and Vice President which will be held on 5 July 2004, Regency/City KPU shall produce "**Temporary Voter ID Cards**" (sample as attached) for additional voters and voters who do not have their own original or temporary voter ID cards.
3. The material for the production of voter ID cards shall be ordinary paper (**non security paper**), laminated, ID-card size, with the following information shown:

Full name :
Date of birth/age :
Gender :
Address :
4. The number of temporary voter ID cards printed shall be compatible with the actual number of potential additional voters. This is to avoid the misuse of those voter ID cards.
5. The cost of the production of voter ID cards shall be borne by the Central KPU with a budget allocation Rp. 400 (four hundred rupiahs) per voter ID card.
6. Regency/City KPU shall record the number of additional voters in each Regency/City KPU speedily and accurately, and shall report the registration results to the Central KPU as a basis for budget allocation.
