Liberians Vote in Delayed Special Senate Elections

Originally slated for October 14, 2014, Liberia's special senatorial elections were moved to December 20 due to the Ebola outbreak. Amid this public health crisis, Liberians headed to the polls to choose half of the country's 30-member Senate for an election that was an important marker of the progress made in the fight against Ebola.
