1. Request for Application (RFA)

1.1. Purpose

The purpose of this Request for Applications (RFA) is to invite civil society organization(s) to submit applications to implement IFES' Chiragh-se-Chiragh (C2C) youth leadership and civic engagement training program. The objective of this project is to strengthen civic knowledge among young people in Pakistan through civic education and development of leadership skills. The RFA provides prospective organizations with the relevant operational and performance requirements. IFES anticipates issuing multiple awards under this RFA.

1.2. RFA Schedule

2. General Information

2.1. Background

3.3.3. Addenda

IFES will make a good-faith effort to provide written responses to the questions or requests for clarifications that require addenda by the date set in the RFA Schedule above. All questions, answers, and addenda will be shared with all interested organizations.

3.4. Eligibility

Locally registered Disabled Persons Organizations (DPOs), Civil Society Organizations (CSOs), Non-Governmental Organizations (NGOs), Community Based Organizations (CBOs), Non-Political Party Organizations or other similar not-for-profit institutions are invited to apply. If a DPO, CSO, or NGO is not locally registered, a signed letter stating the reason why must be included as part of the application.

Individuals and the following organizations are **not eligible** to access funding:

- Governmental and semi-governmental institutions
- International organizations
- Political parties or organizations affiliated with or engaging in partisan activities
- Organizations running on a for-profit basis

3.5. Application Instructions

All applications should include the following, in order for their application to be considered:

3.5.1. Technical Application

The Technical Application must include a written application in English describing in detail the applicant's (a) Technical Approach, (b) implementation timeline, and (c) results framework to implement the Program Description as described in Article 4 of this RFA. The evaluation criteria can be found in Article 3.6. Applicants should use the technical narrative template in Attachment A.

3.5.2. Cost Application – Budget & Budget Narrative

- The Budget should reflect costs associated with the technical activities and deliverables. All applicants must use the budget template provided in Attachment B and submit it in Excel format as part of their application. The Budget should be presented in USD, with applicable taxes/charges clearly identified. Unit costs are required and, in the case of discrepancies between unit costs and total costs, the unit cost will be taken as the reference basis in the evaluation.
- The applicant must agree to keep these costs valid for a minimum of 90 calendar days.
- The Cost Application should include a Budget Narrative that describes each cost element of the Budget (see column H of Attachment B).

3.5.3. A brief outline of the applicant's organization and experience.

Organizations should demonstrate prior experience working with young people from a wide range of states and regions, particularly rural areas, facilitating training programs, and working on programming such as youth leadership, civic education, and/or elections.

3.5.4. Additional documentation

- When available, a copy of the organization's most recent final, signed audits/financial • statements
- Proof of organization's registration or a signed letter indicating why the organization is not registered.
- CVs of key personnel including the organization's Director and anticipated program manager
- Any other supporting document that will strengthen the application

3.6. Application Submission

Applicants must send final applications in electronic copy via e-mail to the point of contact identified in 3.3.1 on or prior to the closing date and time shown in the Schedule of Events.

3.7. Criteria for Selection

The evaluation of each response to this RFA will be based on its demonstrated competence, compliance, format, and organization. The purpose of this RFA is to identify those organizations that have the interest, capability, and financial strength to implement the project as described in Article 4 of this RFA.

3.8. Selection and Notification

Applicants determined by IFES that possess the capacity to compete for this project will be selected to move into the negotiation phase of this process. Written notification will be sent to these applicants via e-mail. Those applicants not selected for the negotiation phase will also be notified.

4. Scope of Work

IFES is implementing the Building Understanding and Involvement in Local Governance and Democracy (BUILD) project with funding from the United States Agency for International Development (USAID). Under BUILD, IFES will implement the Chiragh se Chiragh (C2C) initiative to bolster civic knowledge among young people. C2C is a leadership and civic engagement training program for youth in universities and colleges. It equips young leaders with soft skills and information related to fundamentals of human rights, gender equality, inclusion of marginalized groups, climate governance, democracy, elections and civic/voter participation. At the end of the training program, participants will design and implement post training action plans to conduct education and outreach activities to community members, employing both in-person and online methods.

IFES is looking for local civil society organization (CSO) partners for implementation of the C2C project in the selected districts of Sindh, Balochistan and Khyber Pakhtunkhwa as detailed in the following table.

Please note that the bids must be for one province only, however organizations may, if interested in working in more than one province, submit multiple proposals for each province separately.

Under the C2C program, CSO partners will be expected to carry out the following project requirements:

- Identify higher education institutes (universities, colleges, etc.) as partners for the C2C initiative. The list will be finalized in consultation with IFES.
- Coordinate and sign Memorandums of Understanding (MoUs) with selected higher education institutes as a basis for planning and implementation of joint activities under the C2C project.
- Develop criteria and a process for selection of students/participants from the partner universities/institutes and select C2C training participants according to the set criteria. These criteria should be inclusive of women, persons with disabilities, minorities, transgender individuals, and rural and urban participants to ensure diversity of participation.
- Identify and engage trainers to attend the training of trainers (ToT). IFES will provide Lead Trainers to conduct the ToT and will also bear all training venue costs.
- Conduct a set of C2C Youth Leadership and Civic Education trainings, support participants to develop and implement action plans following these trainings, and arrange award ceremonies and lessons learned workshops for star performers (see below for required details).

- Adhere to IFES' Do-no-Harm approach ensuring safety of project staff and any of the direct beneficiaries.
- Develop a recording and reporting system, in consultation with IFES, ensuring that the implementation process is well documented. This should include a focus on tracking and verifying C2C Alumni performance, including development and implementation of their respective action plans.
- To ensure sustainability and impact beyond the project duration, institutionalize the C2C methodology within the university/institution by building capacity of staff and establishing systems for engagement of students on C2C model.
- Develop innovative methods for networking of the C2C alumnae beyond project duration on the topics around advocacy and citizen engagement.

Applications must include the following activities in their budgets:

- Conduct two-day C2C Youth Leadership and Civic Education Trainings with 20 participants per training. Participants must consist of at least 50% women. This requirement applies to the overall list of training participants across all trainings. At the end of the training, each participant will develop an action plan, targeting to reach out to a minimum of 10 beneficiaries for education/awareness using C2C curriculum and methodology.
- Refine and design IEC materials like posters, handouts, handbooks and banners for use during C2C trainings and for subsequent community awareness/education sessions.
- Arrange an award ceremony for appreciation of the C2C star performers based on their performance working closely with the relevant university/educational institute administration/management.
- Organize a project closeout event and lesson learned workshop with the best of the C2C performers from all selected educational institutes, focal persons/VCs, trainers, etc.

Reporting and Monitoring:

- Submit program progress, event reports, M&E reports and final report on weekly, monthly and quarterly basis or as required by IFES.
- Provide IFES with participant lists, photographs of trainings, monitoring and evaluation data and training reports for each training.
- Participate regularly in project coordination/progress review meetings arranged by IFES (online or in-person).

5. Functional Requirements

5.1. Timeline:

Applicants must submit a detailed timeline in their Application showing the time required to implement the services requested. IFES requires all deliverables to be completed not later than June 30, 2025 for programs in Balochistan or Khyber Pakhtunkhwa, and January 31, 2026 for projects in Sindh.

5.2. Monitoring & Evaluation

- As part of its due diligence, IFES conducts pre-award surveys on all potential grantees to assess capacity and inform the appropriate grant mechanism. In addition, applicants expected to expend \$750,000 or more in U.S. funded awards during their fiscal year must have an audit conducted in accordance with 2 CFR Part 200, Subpart F—Audit Requirements. If Applicable, applicants must ensure that funds are included in the grant budget for an audit.
- IFES will issue the appropriate grant mechanism depending on the nature of the work, the

capacity of the grantee, the duration of the grant, and the overall value of the grant.

• IFES will provide continuous mentorship, training and oversight to ensure grant management practices are in line with anti-corruption principles as well as to build capacity of local grantees to fully manage and implement their programs in adherence to donor regulations and with a view towards sustainability.

5.3. Deliverables:

Specific deliverables and reporting will be determined based on the grant activities proposed and negotiated during the negotiation phase.

6. Additional Terms & Conditions

6.1. Non-Disclosure Agreement

IFES reserves the right to require any applicant to enter into a non-disclosure agreement.

6.2. Zero Tolerance for Fraud
