


### ARTICLE III LEGISLATIVE BRANCH COUNTY COUNCIL

County Council: Composition and Terms

<u>Present Provision</u>: Section 3-2 of the Charter of the County of Hawaii presently provides for a nine-member council, six being residents of six geographical areas and three at-large. All members serve four-year terms.

Proposed Amendment: Section 3-2 of the Charter of the County of Hawaii would be amended to provide that, "One member shall be elected by the qualified voters from each of the nine council districts as established by the county reapportionment commission." In addition, under new Section 3-2.1 a reapportionment commission would be created to apportion the council seats every eight years. The first election under the reapportionment plan would be held in 1988. No residency requirements for the council members are stated. All council members would serve four-year terms.
