

MARCH

8 Presidential Preference Primary

APRIL

8 *Last day to qualify to seek the nomination of either the Democratic or Republican party for the June 7 primary election. (§17-16-11(a))

Independent candidates for state, district, or county office must file petition for ballot access by 5 p.m. this date. (§17-7-1(a))

- 13 Candidates must appoint a campaign committee no later than five days after qualifying for primary election. Thus, earlier qualifiers must file prior to this date. (See "Glossary of Terms.")
- 18 Candidates for state office must file a statement of economic interests no later than 10 days after becoming a candidate. Thus, early qualifiers must file prior to this date. (See "Glossary of Terms," and "Filing Requirements for State Office Candidates.")

BALLOT ACCESS: HOW YOU QUALIFY

TO BE A NOMINEE OF THE DEMOCRATIC **OR REPUBLICAN PARTY*...**

Qualifying to be the nominee of the Democratic or Republican party means filling out what is called a declaration of candidacy, and usually paying a qualification fee set by the party. If you want to run for Congress, a state office, circuit, or district office, you should qualify with the state party of your choice. If you are running for a county office, you qualify with the county political party. All qualification papers must be filed on or before 5 p.m. on April 8, 1988. The beginning date for qualifying is set by the political party. Proper qualifying forms should be obtained from the state party office. (See "Important Addresses and Phone Numbers.")

TO BE THE NOMINEE OF ANOTHER POLITICAL PARTY ...

If you wish to seek the nomination of another political party, contact the chairperson of that political party. The political parties which received less than 20 percent of the vote in the last general election may nominate candidates for the general election only by mass meeting, beat meeting, or convention. These meetings must be held on or before April 8, 1988. Notice of the time and place of meetings should be filed with the Probate Judge in the county where the meeting is to be held at least five days in advance, and the time and place announced in a newspaper of general circulation in the county. If you are nominated by such a political party, your nomination will be certified to the Secretary of State, if it is a state office you are running for, or, to the Probate Judge for a county office, no later than 5 p.m. April 8, 1988. Attached to that certificate of nomination will be a certificate signed by you stating that you will accept your nomination.

ASSISTANCE IN VOTING INFORMATION GIVEN

A person who needs assistance at the polling place due to a physical handicap or illiteracy may receive help in applying for an absentee ballot and/or in the actual process of voting either in person or by absentee ballot. A person needing assistance may ask anyone of his choice, except his employer or agent of the employer on an officer or agent of the voter's union. If a voter does not request a specific individual to aid him, an election official may assist the voter. In either case, a poll worker must have a request for assistance form completed before assistance may be given. (§17-8-29, Code of Alabama and Section 208, Voting Rights Act of 1965, as amended.)

IF YOU ARE A REGISTERED VOTER, YOU MAY VOTE ABSENTEE IF:

- 1. You will be out of the county on election day; or
- 2. You are ill or have a physical disability which prevents you from going to the polls; or
- 3. You are a member of the armed forces, are employed outside the U.S., are away at college, or are the spouse or child of such a person.

WHEN TO APPLY FOR AN ABSENTEE BALLOT:

Since a voter is entitled to vote only in one political party's primary election, a voter must designate in which party's The absentee election managers of the 67 Alabama counties primary he chooses to vote when making an application to vote will begin accepting applications for absentee voting for the in primary elections. TO RUN AS AN INDEPENDENT CANDIDATE ...

If you want to run as an independent candidate in the general election, you will have to file a petition on or before 5 p.m. April 8, 1988. If you are running for a county office, file a petition containing the names of not less than one percent of the registered voters of the county with the Probate Judge. If you are running for a state, circuit, or district office, your petition must contain the signatures of not less than one percent of the total number of registered voters in the state, circuit, or district, and must be filed with the Secretary of State.

TO RUN AS A WRITE-IN CANDIDATE ...

If you wish to run as a write-in candidate, you do not have to qualify with anyone, but you must get voters to write your name on the ballot on election day. Election officials may instruct the voter how to write-in a person's name which is not printed on the general election ballot. You may not run as a write-in candidate in a primary election.

HOW AND WHEN TO RETURN ABSENTEE BALLOTS:

Completed applications for absentee ballots and voted ballots must be returned to the absentee election manager by the voter in person or by U.S. mail.

Absentee ballots must be received by the absentee election manager by the time the polls close on election day.

TRAINING SEMINAR FOR BOARDS BIG SUCCESS!

The Office of the Secretary of State joined with the Alabama Association of Boards of Registrars on December 2, 1987, in holding a comprehensive training seminar for all Boards of Registrars at the Governor's House Motel in Montgomery.

Approximately 70 percent of all the members of the Boards of Registrars from across the state attended the seminar. Topics covered in the workshops included Voter Re-identification--How to Work Within the Guidelines of Act 84-389; Setting Up Filing Systems, Manual or Computer; Filling Our Applications/ID Cards; Using Deputy Registrars Effectively; Effective Office Communication; and Voting Accessibility for Elderly and Handicapped Citizens.

Secretary of State Glen Browder greeted the registrars at the opening session. Throughout the day, members of the Appointing Board (Governor Guy Hunt, State Auditor Jan Cook, and Commissioner of Agriculture and Industries Albert McDonald) spoke to the group.

Secretary of State Browder stated, "I am very pleased to see the tremendous turnout of registrars from across the state for this type of training conference. I hope that seminars such as this can be held on a regular basis in order to increase the professionalism of our registrars and keep them abreast of the latest changes in our registration laws and procedures."

The workshops were conducted by Dr. Robert Montjoy of Auburn University, Anita Tatum of Montgomery County, Ethel Knapp of Elmore County, JoAnne Anderson of Morgan County, Brenda Riley of Madison County, Inez Martin of Chilton County, Anita Petrey and Wondal Whitt of the State Department of Education, Barbara Crozier of the Attorney General's Office, Lois Morris of Lamar County, Billy Compton, Administrator of Elections, and Jerry Henderson, Elections Specialist, both of the Secretary of State's Office.

GLOSSARY OF TERMS

ANNOUNCEMENT OF CANDIDACY

Courts have held that the announcement of candidacy is actually the point at which you qualify to run for the nomination of a political party or as an independent candidate with the Secretary of State or Probate Judge.

CAMPAIGN COMMITTEE

A campaign committee is sometimes referred to as a political committee. Within five days after you qualify (announce your candidacy), you must file a list of the names and addresses of the people you have selected to be your campaign or political committee. You may have from one to five persons serving as your campaign committee, or you may decide to serve as your own campaign committee. Forms may be obtained by writing to the Secretary of State's office. Your committee is responsible for all money received and expended for the purposes of the campaign. If you run for a state office, you file with the Secretary of State. If you run for a county office, you file with the Probate Judge. Each person serving on a campaign committee must indicate in writing his acceptance or consent to serve on the committee.

BALLOT ACCESS

Ballot access is the procedure to make sure your name is printed on the ballot. You may be the nominee of a political party, an independent candidate, or a write-in candidate. (See "Ballot Access ..."for details.)

CAMPAIGN FINANCE DISCLOSURE

State law and the rules of some political parties require each candidate (and/or your campaign committee) to file a list of your contributors and your expenses for the campaign. You should contact your political party if you are going to run in a primary election to see what rules it has regarding campaign finance disclosure.

Under state law if you have opposition in a primary election, you must file a campaign finance disclosure statement within 15 days after the primary or primary run-off election and within 30 days after the general election. This disclosure statement must be subscribed and sworn to by the treasurer of the campaign committee or you, if you are serving as your own committee, stating that the information given in the statement is in all respects true and correct. If you are not your own committee, then you must attach an affidavit to the disclosure filed by your committee subscribed and sworn to by you as the candidate stating that the statement is to the best of your knowledge and belief in all respects true.

Under state law you must disclose the following: names of all contributors of amounts in excess of \$10, listing the amount; a list of all gifts, loans or contributions; an itemized list of all expenditures in excess of \$5 stating who the expenditure was paid to, the nature of the expenditure, and the purpose of the expenditure.

Forms for filing may be obtained from the Secretary of State.

GENERAL ELECTION

The general election will be between the party nominees and any independent or write-in candidates.

PRIMARY ELECTION

The primary election is held by the political parties to select each party's nominee for an upcoming general election. In the primary, Democrats run against other Democrats, and Republicans run against other Republicans.

PRIMARY RUN-OFF ELECTION

Sometimes this is referred to as the second primary. If there are three or more candidates in your race, and if no one receives a majority, a second, or run-off election, will be held between the two candidates who receive the highest number of votes in the first primary. The winner of this election will be the party nominee (or party officer if it is a party office which is being sought).

STATEMENT OF ECONOMIC INTERESTS

Within 10 days after you become a candidate for state office you are required to file a statement of economic interests with the State Ethics Commission. You may obtain copies of the form by writing to the Ethics Commission. This statement is a public record of your personal finances. Should you fail to file the form, your name may be removed from the ballot. If you have any questions, the State Ethics Commission staff will be pleased to assist you. (See "Important Addresses and Phone Numbers.")

TO VOTE YOU MUST REGISTER

Who may register to vote?

Any U.S. Citizen who

- resides in Alabama
- is 18 years old or will be 18 years old by the next election
- is not convicted of a disqualifying offense
- has not been legally declared mentally incompetent

When may I register to vote?

Year round, except:

- registration cuts off 10 days prior to any election
- Because some boards of registrars are not full time, you should contact your local board of registrars to see when its office will be open.


Where may I register to vote?

Register in person at the board of registrars located at the county seat of your county of residence. You may also contact the board for the nearest deputy registrar who can accept your application and return it to the board.

May I register to vote by mail?

Only the following individuals may register to vote by mail:

- members of the armed forces
- persons employed outside the United States (continued next page)

- persons absent because of attendance at institutions of higher learning
- the spouses and children of such persons

What should I do if I have changed my address or my name since the last election?

You should immediately notify the board of registrars in your county where you are registered.

What should I do if I move to another county within the state? You must re-register with the board of registrars for your residence jurisdiction.

MAKE YOUR VOTE COUNT REGISTER, THEN VOTE!

Do I have to register for each election?

No. Registration is permanent, as long as you continue to live in your county of residence and keep your address current with the board of registrars.



When Are The Polls Open?

Polls must open no later than 8 a.m. and close no earlier than 6 p.m. and not later than 8 p.m. Polls must stay open at least 10 consecutive hours. Contact your local probate judge or board of registrars for the hours your county's polls will be open on election day.
