













# YOUR VOTE MAKES A DIFFERENCE









### BOARD OF REGISTRARS: SPEECH

On behalf of the \_\_\_\_\_County Board of Registrars, I thank you for this opportunity to come before you to speak about the importance of voting.

This year it will be our responsibility to select not only our next President and Vice-President, but other important federal and state officers as well. These include United States Senator, United States Representative, Justices of the Alabama Supreme Court, the President of the Public Service Commission, and other offices.

I use the words "our responsibility" because we, as citizens, are ultimately responsible for the effective operation of our government. This civic duty of ours has been handed down to us from our founding fathers, who fought that they, and their descendants, would be able to be independent, self-sufficient, and wholly responsible for their lives and their government.

So, it is clear that Freedom necessarily Entails the Duty of the citizen to exercise it and protect it by Voting.

As we look around the world we see many who are deprived of their right to vote. The ballot box, the voting machine, and the sight of canvassing candidates are completely unknown to them. They have no voice in the way their government is run; nor do they have any control whatever in deciding who will make the decisions which affect their lives. But, of course they are not burdened with the responsibility of voting. And, they are not bothered by political ads and door-to-door campaigners who ask

for their support on election day.

To some, this may not sound like a bad situation. I submit that the following figures speak for themselves:

In the most recent statewide election, on March 11, the 1980 Presidential Preference Primary, 78% of the registered voters of Alabama did not participate. Only 22%---one fifth of the registered voters---cast their vote to help decide the Democratic and Republican nominees for the highest, most powerful office in the world. This means only 17% of the voting age population of the state of Alabama voted on March 11th.

Something is wrong. Don't you believe that the overwhelming majority of voting age citizens of this state care who the next President will be? However, we must all face the fact that the figures do not support this statement.

Voter apathy is not a phenomenum solely confined to Alabama. It is a nationwide problem. And seemingly it gets worse every four years. As Alabamians, we cannot solve the problem for the entire nation, but we can make some positive strides here in our own state.

How? By <u>all of us</u> of the Voting Minority making a concerted effort to encourage those of the Apathetic Majority to exercise their right to vote.

This can be done in several ways: Through advertisements, public service announcements, personal contact, and through the use of voter registration drives aimed at those who are not registered to vote. Part of our emphasis should be on encouraging registered voters to vote, since the majority of those who do not

### vote are registered voters.

We all must realize that <u>every vote does indeed count</u>, not just because one vote may decide an election—which can happen—but because voting is a far more effective way of improving government than complaining.

In Alabama, rarely do we have an election year wherein some office is not won or lost by only a handful of votes. This year many of the political experts are predicting a close Presidential race---all the more reason why each vote is important.

However, close Presidential elections are nothing new. Many of you may recall the historic 1960 Presidential election in which John F. Kennedy won with 49.72% of the vote, as against Richard Nixon's 49.55%: a difference of only .17%......Less than 2 tenths of a percent. It wouldn't have taken a vote-change by many to have changed the course of history.

Again, in 1968, the percentage difference between the two major candidates, Richard Nixon and Hubert Humphrey, was almost negligible: Nixon received 43.42% while Humphrey drew 42.72%..... a difference of only 7 tenths of a percent. Yes, this difference was almost negligible, but it decided who would be the President of the United States for the next four years.

These figures indicate how only a few votes can seperate the winner and the loser. But, it is important to keep in mind that every vote is important in all elections, whether the winner wins by less than 1% or by a landslide. Each vote represents a voiced petition of how government should be run. And this method of lodging our opinions can obtain results much more effectively than

idle complaining.

Idle complaining did not choose the Democratic and Republican nominees for President.

We are a democracy of the people: We cannot afford to become a government of the few, by the few, and for the few. If we want the elected officials of this country to respond to the wishes of the majority, the majority must show their concern by voting. Furthermore, if we want our country to remain strong, we must strengthen ourselves internally.

While voting statistics show that people are frustrated, cynical and distrustful of politics, government and politicians, one thing is certain: That if we want to change we will have to work for it.

Nothing comes free or easy. Things will not get better by themselves. And, if we want good government, we will have to work for it.

Too often people sit around the kitchen table discussing issues or cursing politicians for doing nothin, or for doing things wrong. They discuss the complex, seemingly insolvable problems of inflation, energy, jobs, welfare, clean air, clean water, etc. Then they curse the elected officials for not doing the obvious, the so-called "easy things" such as fixing the roads or what-have-you.

All this negative energy should be harnessed and turned toward positive change. One thing is certain, and that is that nothing will change unless we the people change it. Things will not get better, but rather worse unless we do something.

Thomas Jefferson said:

r.

"I know of no safe depository of the ultimate powers of the society but the people themselves. Whenever the people are well informed, they can be trusted with their own government; whenever things get so far wrong as to attract their notice, they may be relied upon to set them to rights."

Yet, in order for the people to be able to have that positive affect on government, they must be able to participate, they must be able to have their voice heard and their will felt. Our ultimate recourse, to right wrongs, is our right to vote.

While our problems may be great, while there may be world turmoil which we as a single voter may not be able to correct, I believe that we can solve our problems no matter how complex thay may seem.

I beliebe that we can have a government that is just as good, decent and honest as the American people.

I believe that we can meet the demands of the 1980's and the challenges of the future.

However, it will take all of us working together to make it happen.

We must be willing to register our opinions by registering to vote, and voting for those people or political parties which best represent our views.

We must be willing to spend a little of our time, the same as we do for our church or civic organizations, to make our government work the way we all know it can and should.

Therfore, I call on all of you to join me and the other Boards

of Registrars in this effort to reverse the trend of declining voter participation. We can improve our government and we can make our officials more responsive to our needs. To do this we have to jump into the process and vote and work within the political system.

REMEMBER: YOUR VOTE DOES MAKE A DIFFERENCE!

### ELICIBILITY TO REGISTER AND VOTE

Must be 18 years of age	Provided no conviction of certain crimes and not insane. (Sec. 182 of Ala. Constitution)
Residency	Ten (10) days before he or she may become eligible to register to vote. (Attorney General's opinion dated July 25,1977)
Deadline to register before election	No person may be registered as a qualified elector within 10 days prior to any election. Jefferson County - 21 days prior to any election.
1. Registration by Mail	.*Members of the armed forces of the U.S., persons employed outside the U.S., and the spouses and children of such persons. Eligible to register in counties where they were residents prior to entering the above status. **Persons who are absent from the county of their residences because of attendance at an institution of higher learning and their spouses and children.
2. Request for application	Request must be done in writing and filed with the Board of Registrars of the county in which the elector resides.
3. Questionnaire must be subscribed and sworn to	*By a commissioned officer of the armed forces of the U.S., or any officer authorized to administer oaths and take affidavits.  **Presence of an officer authorized to administer oaths and take affidavits.
	Within thirty days after denial, by filing a complaint in the circuit court in the county in which he or she seeks to register.

### ABSENTEE VOTING

which prevents his attendance at the polls, whether he is within or without the county on the day of the election, may vote an absentee ballot.

- 2. Time for filing for application.....Must make application in writing not more than sixty (60) nor less than five (5) days (17-10-3)prior to the election.
- 3. Postcard application for certain (17-10-3)

military personnel and wives......An applicant who is a member of the armed forces of the U.S., including the Ala. National Guard, the United States naval reserves, the United States air force reserves and the United States military reserves on active duty training or an applicant who is the wife of any member of the armed forces may make application for absentee ballot by filling out the federal postcard application form. (17-10-3)

4. Form and contents of application ..... Form need not be in any particular form, but must contain sufficient information to identify the applicant as the person he claims to be. Must include: applicant's name, age, sex, address, precinct in which he last voted and the address to which he desires the ballot to be mailed.

- 5. Who application must be filed with....Register or register in chanchery. If no (17-10-4)register in a county, the clerk of the circuit court.
- 6. Assistance in filling out (17-10-4)

out the application but must be manually signed by the applicant. If he signs by mark, the name of the witness to his signature must be signed thereon.

7. Doctor's certificate required (17-10-4)

account of any physical disability, the application shall have attached thereto a certificate signed by a licensed practicing physician of this state, certifying where the applicant is confined and describing his or her physical condition and stating that he or she will be physically unable to go to his or her polling place on election day.

8. Absentee ballot must be sworn to before a notary public or other officer authorized to acknowledge oaths, with the exception of..... (17-10-6)

oaths, with the exception of...... A person confined on account of physical (17-10-6) disability to a hospital, nursing home, rest home, or sanitarium may in person execute the affidavit on the ballot before the authority in charge.

A person who is a member of the armed forces of the U. S., etc., may make the affidavit on the ballot before any officer authorized to administer oaths or before the commanding officer or other authority in charge.

9. When ballots, envelops, etc.
delivered to clerk or register.....Not less than twenty-one (21) days prior
(17-10-12) to the holding of any election.
