VOTER REGISTRATION IN ANNE ARUNDEL COUNTY

Call Voter Information Service (VIS) (410) 222-6611, 24 hour service, for information on registration and voting, or to leave a recorded request for a registration application or an absentee ballot application. **BE SPECIFIC**.

QUALIFICATIONS

You must be a United States citizen and a resident of Anne Arundel County on the day you register. You must be at least 16 years old on the day of registration and 18 years old by the next General Election. For 2000, the crucial date is 18 years old by November 7, 2000 or born on or before November 7, 1982. Anyone who qualifies for voting in the General Election also qualifies for voting in the Primary Election that precedes it; thus some 17 year olds may vote in the Primary. On General Election day, however, all voters must have reached their 18th birthday.

<u>HOW</u>

Registration is a two step process - application and notification.

Application for voter registration may be made by mail or in person. Once the application has been reviewed and approved by the election office, the new voter is sent a Voter Notification Card which confirms his registration and shows the voter's choice of party affiliation, date of registration, Councilmanic District and Precinct, Legislative District, Congressional District and polling place location. The Voter Notification Card is always sent by non-forwardable mail.

REGISTRATION IS NOT COMPLETE UNTIL THE VOTER NOTIFICATION CARD IS RECEIVED BY MAIL.

<u>WHEN</u>

Year-round, except that application forms are not processed when the books are closed. They close 24 days prior to any election and remain closed until 10 days after a Primary, General, or Special Election. Applications received by the office during the period the books are closed, will be processed when the voter registry reopens.

Applications may be secured by phoning: Election Office (410) 222-6600, 8:00-5:00 or VIS (410) 222-6611 any time day or night (leave recorded message).

Registered voters may volunteer to assist with voter registration by becoming a "Voter Registration Volunteer". They are required to take a brief training class in the Election Office. Call (410) 222-6600 for more information.

Additional registration sites may be scheduled at various locations in the weeks preceding the closing of the registry before each election.

On the final date for registering to vote before the Primary and General Elections, the Anne Arundel County Public Libraries are staffed with registrars to accommodate the citizens of Anne Arundel County.

Registration is available at Motor Vehicle Offices at the time of issuance or renewal of a driver's license, and is also available to all public high school students during High School Registration Week.

Registration is permanent unless the voter advises us in writing that they have moved to a jurisdiction other than Anne Arundel County.

TO CORRECT OR UPDATE VOTER REGISTRATION INFORMATION

CHANGES OF ADDRESS AND/OR NAME are accepted any time the registry is open.

Changes may be made by mail or in person, but must be in writing and bear the voter's signature. Send such requests to the Board of Elections, P.O. Box 490, Glen Burnie, MD 21060-0490. Include printed name, old and new information, date of birth and SIGNATURE.

Voters moving out of Anne Arundel County must register in their new county or state and cancel in writing the Anne Arundel County registration.

<u>CHANGES OF PARTY AFFILIATION</u> are not permitted in the three months prior to any Primary Election (cut-off date for the 2000 Election is December 13, 1999).

Democrats, Republicans, and voters who decline to affiliate with a recognized political party may vote in this Primary Election.

<u>All</u> registered voters may vote for <u>all</u> offices and on <u>all</u> questions which appear on the General Election ballot.

ABSENTEE VOTING BY REGISTERED VOTERS

WHO MAY VOTE BY ABSENTEE BALLOT

- An employee of the State Board of Elections or a local board.
- A registered voter who is absent for any reason from the county.
- A full-time student at a college or university outside the precinct where he is registered but within the county where he is registered, and whose academic requirements preclude the student from being present at the polls on election day.
- An ill or disabled person.
- One confined in, or restricted to an institution.
- A person 65 years of age or older, whose polling place is not accessible.
- Death or serious illness in the immediate family.

HOW TO VOTE BY ABSENTEE BALLOT

Request an application for absentee voting from the Election Office.

THOSE WHO WISH TO VOTE BY ABSENTEE BALLOT <u>MUST</u> MAKE APPLICATION EACH ELECTION YEAR

Be prepared to give the applicant's date of birth, permanent Anne Arundel County address and the address to which the application should be mailed.

Military personnel may request an application from the Voting Officer assigned to their company.

Applications should be requested approximately 4-6 weeks before an election. Completed applications should be returned promptly to: Anne Arundel County Board of Elections, P.O. Box 490, Glen Burnie, Md. 21060-0490.

Applications must be received in the election office by:

- February 29, 2000 for the Primary
- October 31, 2000 for the General

Ballots are delivered to the Board office by the printer approximately four weeks prior to the election. Ballots for applications currently on file are mailed immediately. The ballot for an application received thereafter is mailed the day the application is received.

Voters requiring an absentee ballot after the ballots are received from the printer, may complete the entire process, including voting, by coming in person to the Board office.

Ballots should be voted at the applicant's earliest convenience and returned promptly. A ballot received by the Board will be counted provided:

- It has been received prior to the closing of the polls on election day, or
- It was mailed from a location within the United States before the election, bearing a postmark verifying that fact and the ballot is received from the postal service by 4 PM on the Wednesday following election day.
- It was mailed from a location OUTSIDE THE UNITED STATES before election day, bearing a postmark verifying that fact, and arrives no later than 4 PM on the second Friday following the election.

LATE ABSENTEE VOTING

Late absentee voting is available after the regular absentee deadline under certain circumstances, 7 days or less before the election. However, the application must be made either <u>personally</u> or by an authorized agent in the Board office. Call ahead to be sure you qualify. For additional details call (410) 222-6600 and request the Absentee Voting Department.

SPECIMEN BALLOT MAILINGS

Prior to each election, the Board of Elections mails a Specimen Ballot to each registered voter. The Specimen Ballots sent during a General Election are used also to verify the registration records. Approximately 12% of the Specimen Ballots sent are returned by the Post Office as "Undeliverable." After the election, an "address confirmation postcard" is sent to any of these voters that failed to update their address information at the polling place. Any voter receiving a "Confirmation Postcard" should fill it out, sign it and return it to this office.

BARRIER FREE POLLING PLACES

In accordance with Article 33, Sections 1-101(O) and (S)

"Elderly" means 65 years of age and older and "Handicapped" means having a temporary or permanent physical disability.

Maryland law permits the Election Board to assign an alternate polling place to the elderly or handicapped whose polling place is not structurally barrier free. The request for a change in polling place shall be on a form provided by the Election Board.

An elderly or handicapped voter who is assigned an alternate polling place shall be provided with the same ballot as that of the original polling place.

The application must be received by the Board no later than the closing of registration for any election (February 11, 2000 for the Primary Election and October 13, 2000 for the General Election).

To request applications or for additional information, call (410) 222-6600.

ASSISTANCE IN THE POLLING PLACE

In accordance with Article 33 of the Annotated Code of Maryland, Section 10-310(C)(3):

A voter who requires assistance in marking or preparing the ballot because of a physical disability or inability to read the English language may choose any individual to assist the voter, not to include the voter's employer or agent of that employee, or an officer or agent of the voter's union.

If the voter does not select an individual to assist, assistance may be provided by two election officials of opposite political affiliations who shall record on a form prescribed by the State Board, the name of the voter who required assistance, and the name of the individual providing the assistance. The only assistance which shall be lawful for said person or said officials to give the voter is to mark the ballot or operate the voting unit under the voter's direction, as the voter shall direct without prompting or suggestion.

A voter may not be accompanied into a voting booth by a person over the age of 10, unless the affidavit required has been accepted by the judges of election.

NOMINATION BY PETITION

WHO MAY BE NOMINATED BY PETITION

An individual who meets the legal qualifications for any public office may be nominated by petition as a <u>General Election</u> candidate, but may not be affiliated with either of the political parties which nominate their candidates by a Primary Election (Democrat or Republican parties).

QUALIFICATIONS

Qualifications for office and filing fees <u>ARE THE SAME AS FOR OTHER CANDIDATES</u> who are seeking nomination by Primary Election. (See information relating to "Qualifications for Elected Office").

PETITION FOR CANDIDACY

The petition form prescribed by the State Board of Elections must be used, and complete information must be recorded by each registered voter who signs the petition. Specimen copies are available in the Anne Arundel County Election Office. The candidate is responsible for producing the quantities he needs.

SIGNATURES REQUIRED

To qualify for a place on the General Election ballot, the candidate shall file petition pages signed by not less than one percent of the total number of registered voters who are eligible to vote for the office sought, but not less than 250 registered voters.

The number of registered voters shall be computed from the registration totals on the Monday which is twelve weeks prior to Primary Election Day (December 13, 1999).

A candidate should submit at least twenty percent more signatures than the number of signatures required. Most petitions contain a large number of invalid signatures.

DEADLINE TO FILE PETITIONS

All petition pages must be filed with the Election Board no later than 5 P.M. on August 7, 2000.

FAIR ELECTION PRACTICES LAW

All candidates for public office and all political committees are required to conduct their campaigns in accordance with the Fair Election Practices Law, which is Section 13 of Article 33 of the Annotated Code of Maryland. Summaries of the law are available from the State Board of Elections in Annapolis or from the Anne Arundel County Board of Elections in Glen Burnie. The law is concerned primarily with campaign financing and reporting but includes a section of specifically prohibited campaign practices.

A fund raising account must be established and filed with the appropriate election office prior to the occurrence of financial activity (Statement of Organization for Appointment and Acceptance of Personal Treasurer for a Candidate - Form number SBL-Rev597-26-1, Statement of Organization for a Non-Federal Political Committee or Slate - Form number SBE-13-01(Rev. 3/99).

Account books containing the names and addresses of all persons from whom monies were received and all persons to whom money was disbursed must be maintained by the treasurer.

Periodic, timely campaign fund reports must be filed with the appropriate election office, unless an Affidavit of Limited Contributions and Expenditures is filed on or before the first report due date. Failure to file timely reports results in the automatic assessment of daily late fees.

<u>A person who is serving as Treasurer, Sub-Treasurer, Chairman, or Political Agent</u> for any candidate or political committee in an election <u>may not be a candidate</u> for any public office or party office in that same election. The only exception to this is that a candidate may serve as Chairman of his/her own committee. The election law defines a Political Agent as "any person appointed by any candidate, his representative, a political party or partisan organization to promote or assist in the promotion of the success or defeat of any candidate, political party, principle or proposition submitted to a vote in any election". Thus, campaign committee officers or steering committee members are barred themselves from candidacy.

FINANCIAL DISCLOSURE

State and County Laws require disclosure of financial interests by candidate and office holders. One such law, Section 15 (601-605) of the Annotated Code of Maryland relates to State candidates and officials. County candidates and officials are responsible for filing disclosures under county laws. Disclosure forms may be obtained from the respective offices.




INSTRUCTIONS FOR USING THE OPTECH III EAGLE VOTING SYSTEM
