

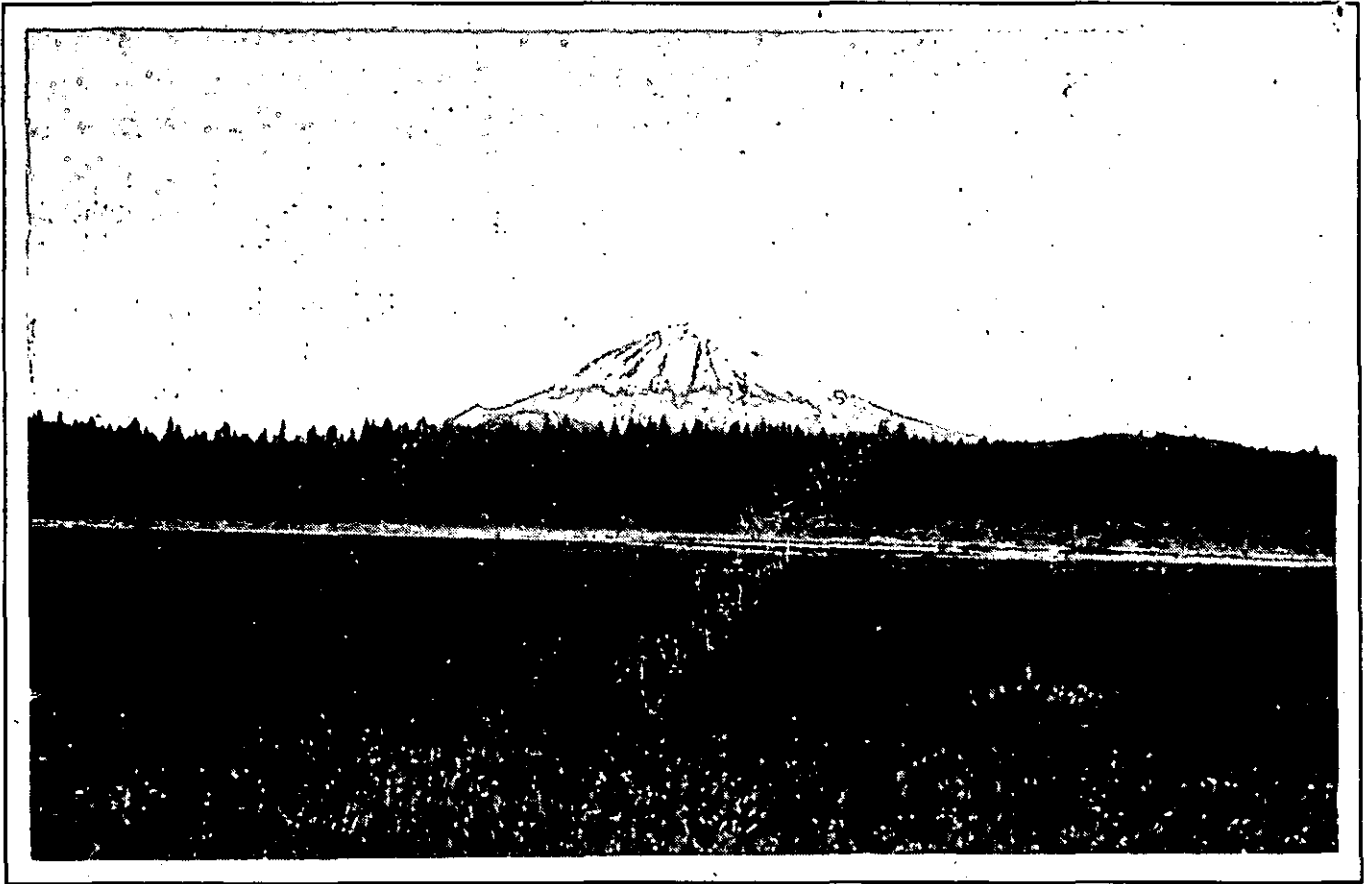

At the March 27, 1990 Regular District Election, you will be asked to make many important decisions. This election will be conducted by mail and you will be voting on your local school district board of directors, a proposed Jackson County community college formation and directors, education service district directors, and funding measures for Rogue Valley Transportation District and the City of Phoenix.

This voter pamphlet is provided to help you become a well-informed voter. In this pamphlet you will find a sample ballot, which lists all of the candidates and measures on the ballot and actual texts of the various measures as well as additional explanatory statements designed to provide you with impartial and fair information about the measures. You will also find arguments by the supporters and opponents of the measures if they have chosen to provide such arguments.

All candidates on the ballot have had the opportunity to submit candidate statements. For candidates who did not wish to provide a statement, biographical information only will be found on the back pages of this publication.

Instructions on how to vote your ballot and return it to the elections office can be found on page 3. Also provided is information on voter registration and election dates for 1990 on page 2.

Remember: All voted ballots must be received by the elections office no later than 8:00 p.m. March 27, 1990 in order to be counted.

VOTER RESISTRATION INFORMATION FOR MARCH 27, 1990 ELECTION

To be eligible to vote in the March 27, 1990 Regular District Election, a completed voter registration card must be on file with the Jackson County Elections Office by not later than 5:00 p.m. on **March 6, 1990**.

YOU MAY REGISTER TO VOTE IF:

1. You are a citizen of the United States.
2. You will be 18 years of age or older on election day.
3. You are a resident of Oregon.

YOU MUST RE-REGISTER IF:

1. Your residence or mailing address changes.
2. Your name changes.
3. You wish to change political party affiliation.

IMPORTANT NOTE: IF YOU HAVE MOVED OR YOUR NAME HAS CHANGED AND YOU HAVE NOT RE-REGISTERED, YOU MAY STILL BE ABLE TO DO SO. CONTACT JACKSON COUNTY ELECTIONS AT 776-7181 FOR FURTHER INFORMATION.

VOTING INSTRUCTIONS FOR THE MARCH 27, 1990 REGULAR DISTRICT ELECTION

When you get your ballot in the mail after March 10, immediately examine it to make certain it is complete. It should contain the following items:

- A computer card ballot on which you may vote your choices;
- A voting guide (ballot pages) from which to determine your choices;
- A secrecy envelope with voting instructions printed on it;
- A pre-addressed blue return envelope in which to return your ballot.

If any items are missing or if you have spoiled your ballot and need a replacement contact Jackson County Elections, 776-7181 and a replacement ballot will be sent to you.

VOTING YOUR BALLOT

Follow the instructions printed on your Secrecy Envelope.

Read the voting guide (ballot pages) showing the candidates and measures. Note the Computer Ballot Card number to the right of the candidate of your choice or the measure response (YES or NO) of your choice.

Find the same number on the computer ballot card.

Place the ballot card on a flat surface. Using a pen or pencil press straight down on the small black dot ABOVE THE NUMBER of your choice. While pressing down slowly lift the top of the ballot card with your other hand until the rectangle containing the black dot is completely detached.

To vote for a candidate whose name is not on the ballot pages, write the complete title — office and position — and the full name of the candidate in the proper space on the write-in portion of the computer ballot card.

If you make an error on your ballot, spoil it in any way or lose it, you may obtain a replacement ballot by contacting the Elections Office at 776-7181.

RETURNING YOUR VOTED BALLOT

Place only **YOUR** computer ballot card in the white secrecy envelope and seal the envelope.

Place the sealed secrecy envelope in the blue return envelope, seal the blue Return Envelope and **sign the statement on the back of the envelope. Your ballot will not be counted if your envelope is not signed.**

Place appropriate first class postage on the blue Return Envelope and mail it so that it is received in the Jackson County Elections Office by 8:00 p.m. on March 27, 1990. **IMPORTANT: YOUR VOTE WILL NOT BE COUNTED IF IT IS NOT RECEIVED IN THE ELECTIONS OFFICE BY 8:00 P.M. ON MARCH 27, 1990.** Election Office hours on March 27, 1990 are 7:00 a.m. to 8:00 p.m. Polling places will not be open on election day.

QUESTION: Shall Rogue Valley Transportation District (RVTD) levy \$670,000 outside its tax base during fiscal year 1990-91 for Transfer Center Construction?

EXPLANATION: This measure would allow the District to levy up to \$670,000 over its tax base during fiscal year 1990-91. The District has acquired land in the Medford core area on the west side of Front Street between 8th and 10th Streets for the construction of a convenient, comfortable and secure Transfer Center. The Center will serve RVTD passengers entering and exiting buses and transferring to buses serving the Ashland, Phoenix, Talent, Jacksonville, Central Point, and White City areas of the District. RVTD has acquired a Federal grant of \$110,000 for use in Transfer Center construction. The proposed levy will provide the additional funds necessary to construct the Center. The total amount levied would not exceed \$670,000. This is a one year levy. The estimated annual tax impact of this measure is 19 cents per thousand dollars assessed value. The estimated tax cost of this measure is an ESTIMATE ONLY based on the best information available from the County Assessor at the time of the estimate.

MEASURE NO. 15-1

Rogue Valley Transportation District

Ballot Title:

One Year Levy For Capital Construction

Question:

Shall Rogue Valley Transportation District (RVTD) levy \$670,000 outside its tax base during fiscal year 1990-91 for Transfer Center Construction?

Explanation:

This measure would allow the District to levy up to \$670,000 over its tax base during fiscal year 1990-91. The District has acquired land in the Medford core area on the west side of Front Street between 8th and 10th Streets for the construction of a convenient, comfortable and secure Transfer Center. The Center will serve RVTD passengers entering and exiting buses and transferring to buses serving the Ashland, Phoenix, Talent, Jacksonville, Central Point, and White City areas of the District. RVTD has acquired a Federal grant of \$110,000 for use in Transfer Center construction. The proposed levy will provide the additional funds necessary to construct the Center. The total amount levied would not exceed \$670,000. This is a one year levy. The estimated annual tax impact of this measure is 19 cents per thousand dollars assessed value. The estimated tax cost of this measure is an **ESTIMATE ONLY** based on the best information available from the County Assessor at the time of the estimate.

Explanatory Statement:

Rogue Valley Transit District has purchased a piece of property on Front Street in downtown Medford between 8th and 10th streets with federal grant funding. This property is to be the site of a bus transfer center. This measure as proposed will allow for that construction to occur.

The transfer center will allow buses to pull into an off-street paved lot where each route will have a designated parking space. The transfer center will also provide a waiting area for passengers, public restrooms and other minor amenities.

The levy cost of \$670,000 used with available capital funding will complete the project. Paving, sidewalks and curbing costs are estimated to be \$310,795, almost half of the \$670,000. The building cost is estimated to be \$191,835. The balance of the levy will pay for shelters, benches, landscaping, lighting, utilities and permits.

This levy will cost property owners approximately 19 cents per \$1,000 assessed valuation one time only. An owner of an \$80,000 home will pay \$15.40 for one year only. Example: $\$80,000 \times .19 = \15.40 .

Over 100,000 passengers ride the Rogue Valley Transit District buses each month. The number of passengers carried on the buses has increased by 325% during the past five years. The transfer center will provide these people with a safe and convenient area to change buses.

Rogue Valley Transit District buses currently meet at an intersection in downtown Medford occupying all available curb space. In 1977 this area was adequate for the 6 vehicles operated by Rogue Valley Transit District. Today, the Rogue Valley Transit District has 24 vehicles serving 16 routes throughout Jackson County and has outgrown the area. This measure as proposed will remove the buses from that intersection at 6th and Bartlett streets.

Rogue Valley Transportation District

ARGUMENT IN FAVOR

Due to the rapid growth in Jackson County, the Rogue Valley Transit District is experiencing increased demand. As we look about our County, we see new homes and businesses contributing to the economic vitality of this area. Rapid growth contributes to demands on transportation facilities. A good bus system and good roads help our area handle the growth we are experiencing by **relieving traffic congestion**, encouraging **energy conservation**, and contributing to **improved air quality**.

With the construction of the **Central Transfer Center**, congestion in downtown Medford will decrease. Getting the buses off the streets and into a safe, convenient transfer point is vital. Your help is needed for the continuation of transit service improvements.

Rogue Valley Transit District buses provide needed service to groups unable to drive cars such as the handicapped, senior citizens, commuters, students, and one-car families. These people depend on **good safe transit**.

The last census taken in 1980 indicates Jackson County's elderly population at approximately 29,000. This figure has doubled since that time. Population figures also indicate handicapped persons of nearly 15,000 needing bus service.

The levy request will allow our transit district to build a bus transfer center. This is a center for all of us. With the revitalization of downtown Medford, the transfer center will be an attractive addition as well as a safe and convenient place for passengers to change buses. It is within walking distance of major downtown shops, businesses, and county and city buildings.

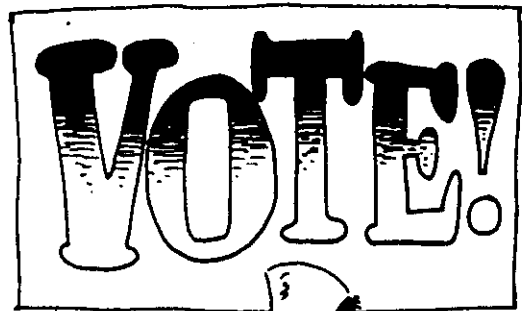
Yes, it will cost something. A one-time tax levy of approximately 19 cents per \$1,000 assessed valuation. That means if your home is assessed at \$80,000 it will cost you \$15 40 **one year only**. This amount is about half the cost of a monthly bus pass.

We need your help and support to continue making improvements in transit service. The addition of this transfer center helps all our citizens.

MEASURE NO. 15-2

The Proposed Jackson County Community College District (Jackson County)

Ballot Title:

To Establish A Community College District For Jackson County

Question:

Shall a community college district comprising Jackson County in its entirety as of March 27, 1990 be established?

Explanation:

To bring community college technical and vocational training, college transfer, self-improvement, community service, and other programs to the residents of Jackson County, State of Oregon. The district is the entire county and is divided into six zones for representation on the board of directors. A seventh at-large zone representing the entire county is also proposed. The zones have been adopted by the State Board of Education.

Explanatory Statement:

This measure proposes the creation of a community college district within Jackson County. The proposed district includes all of Jackson County. If formed, the community college district will bring technical and vocational training programs, college transfer programs, community service programs, and self-improvement programs to the residents of Jackson County.

The proposed district will be governed by an elected seven-member board of directors. Directors will be elected from six geographical zones and one at-large zone. The directors will be responsible for the final design of programs offered in Jackson County.

Jackson County is the most populous area within the State of Oregon that is not currently within a community college district. A feasibility study prepared for the State Board of Education indicated that there is a significant need for additional community college services within Jackson County. In particular, the study cites the need for vocational and technical training programs and developmental education (adult basic skills) programs. At maturity, the proposed college district will have an enrollment of approximately 3100 full-time equivalent students.

In order for the district to be formed, this measure, and the community college financing measure on this same ballot, must both pass.

MEASURE NO. 15-3

The Proposed Jackson County Community College District (Jackson County)

Ballot Title:

To Establish A Two-Year Operating Tax Rate Serial Levy

Question:

Shall district levy 42 cents per \$1000 of assessed value for two years outside tax base for operations beginning 1990-91?

Explanation:

To bring community college technical and vocational training, college transfer, self-improvement, community service, and other programs to the residents of Jackson County, State of Oregon the proposed community college district is seeking estimated net total levies of \$1,663,191 for the 1990-91 fiscal year and \$1,713,087 for the 1991-92 fiscal year. This levy is outside the limitation imposed by the Oregon Constitution, Article XI, Section II. By approving the local serial levy, state funds may be forthcoming to support the district's budget.

Explanatory Statement:

This measure proposes the establishment of a two-year tax rate serial levy to support the operations of the proposed community college district. The proposed tax rate levy is 42 cents per \$1000 of assessed value for two years beginning with the 1990-91 fiscal year. It is estimated that the levy will produce \$1,663,191 in 1990-91 and \$1,713,087 in 1991-92. Future levies must be proposed by the district's board of directors and approved by voters within the district.

The proposed levy is for operating purposes only; the levy does not contemplate the construction of a college campus. It is expected that district programs will be offered in leased and rented facilities.

If the district is formed and the local tax levy is approved, state and federal funds will be available to the new district. These funds will, for the first two years, roughly equal the amount generated by the local tax levy. Student tuition revenues should provide, on average, an additional \$400,000 to the district for each of the first two years.

Tax rates in other regular Oregon community college districts range from a low of 87 cents per \$1000 of assessed value to a high of \$4.25 per \$1000 of assessed value. (1987-88 data)

In order for the district to be formed, this measure, and the community college formation measure on this same ballot, must both pass.

Police Services Three-Year Serial Levy

Question:

Shall the City of Phoenix levy \$185,542 for three years outside the tax base for Police purposes beginning 1990-91?

Explanation:

The purpose of this levy request is to replace the expiring three-year levy and to provide the funds necessary to support current police services. This special levy will continue the current police operations with the addition of a full-time patrolman to be funded out of the General Fund. Police coverage will then be maintained at a 24 hour, 7 days a week level during the next three years. The total amount of the proposed levy is \$556,626, which is to be levied in equal amounts of \$185,542 each of the 3 years. It is estimated that this levy will be \$2.65 per \$1,000 of assessed value this first year. The estimated tax cost for this measure is an estimate only based on the best information available from the county assessor at the time of estimate.

Explanatory Statement:

The purpose of this levy request is to replace the expiring three-year levy and to provide the funds necessary to support current police services. Funds are not available in the General Fund to support current police services. This special levy will continue the current police operations, which include a Chief, Sergeant, two patrolman and a clerk. An addition of a full-time patrolman to be funded out of the General Fund. Police coverage will then be maintained at a 24 hour, 7 days a week level during the next three years. The total amount of the proposed levy is \$556,626, which is to be levied in equal amounts of \$185,542 each of the three years. It is estimated that this levy will be \$2.65 per \$1,000 of assessed value this first year. The estimated tax cost for this measure is an estimate only based on the best information available from the county assessor at the time of estimate.

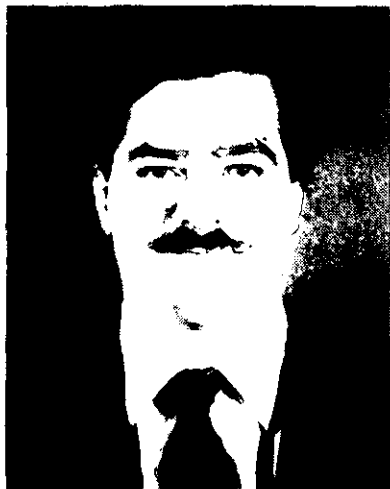

While these are both needed under present circumstances, and accepted by many students, they do not provide the coordinated systems of training that we need. Only a local community college can best provide this type of training that we are now without. Adding a Jackson County Community College is not a duplication; it is filling a void that now exists. The State Department of Education representative estimates that a minimum of 1,200 F.T.E. (full-time equivalency) students would be enrolled in a Jackson County Community College by the start of the second year of operation.

The State Board of Education has approved a ballot issue to establish our own community college recommending a levy of 42¢ per 1,000 valuation. Many candidates for the Board of Directors believe we can provide quality education for as little as 24¢ per \$1,000 valuation.

The levy will provide funds to operate public libraries in Jackson County. The 1988 levy approved by voters provided 95% of the money needed to operate libraries. That levy ends on June 30, 1991. The new levy will keep branches open; rent and maintain buildings; and continue other basic library functions. It will maintain services to the elderly and homebound, to children, and to teens. The new levy will also buy books and non-print materials and provide reference services. It will permit planning for future services and facilities. The funds needed for 5 years total \$20,500,000. This sum will be levied in equal amounts of \$4,100,000 in each of 5 years.

Explanatory Statement:

The Jackson County public libraries have operated for the past 6 years with funds from serial tax levies in excess of the 6% limitation. The levies were approved by the voters in 1984 and 1988. The 1988 levy ends on June 30, 1991. The proposed levy will keep libraries operating at the current level of services. In addition, the collection of books and non-print materials will be improved. Current service levels require purchase of books for circulation; payment of salaries, rent, and utilities; and provision for equipment and supplies. It includes reference service to business and community members, delivery of books to the homebound, and library programs for children and teens. The proposed serial levy, if approved, would be levied at a rate not exceeding \$4,100,000 in each of the fiscal years 1991-92, 1992-93, 1993-94, 1994-95, and 1995-96.

Rogue River School District No. 35

Ballot Title:

School District No. 35 Capital Construction or Improvement Bond Issue

Question:

Shall the District issue \$510,000 in bonds to mature within 20 years for capital construction or improvements of District facilities?

Summary:

The bond issue is to provide funds for capital construction or improvements to the Rogue River Elementary School, Middle School, and High School, the Evans Valley Elementary School, the Administration Building of the District and the respective building sites; the term of the bonds shall not exceed 20 years from issue date; the bonds will be general obligations of the District and taxes levied for principal and interest on the bonds shall be exempt from the limitation of Article XI, Section 11b of the Oregon Constitution.

Explanatory Statement:

The revenue from the proposed bonds will be used for capital improvement or construction at the four school sites in the Rogue River School District. A complete list of all the items proposed and their estimated costs were provided for public review and comment before they were approved by the School Board.

The School District has available for any interested person, a comprehensive detail, including pictures, of each proposed project. They may be obtained at the District Office.

Briefly summarized the projects are: 1) Replacement of deteriorating and leaking roofs; 2) Refurbish elementary school gym including floor; 3) Replacement of cafeteria/kitchen equipment; 4) Improvement of driveways and parking areas; 5) Ceiling repairs and insulation caused by leaking roofs; 6) Replacement of carpeting; and, 7) other miscellaneous items.

The School Board has pledged after payment of the costs of issuance and of the needed improvements, the remainder of the proceeds of the bond sale will be applied to the payment of the outstanding bonds as provided by Oregon Law. None of these funds may be used for school operating expenses.

It is anticipated that the bonds will be issued at a rate not to exceed 8% per annum and will be retired over a 20 year period. Based on the District's present assessed value, the tax rate would increase approximately \$0.21 per thousand dollars assessed value. This would result in a tax increase of about \$16.80 per year for a \$80,000 home. It should be noted that the only bonds outstanding at the present time are bonds which were issued to build the high school. The tax rate necessary to pay the present bonds is approximately \$0.66 per thousand. They will be paid off in June 1994.

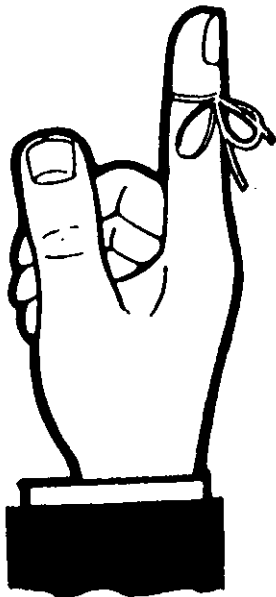
