SCHEDULE  
BOUNDARIES OF CONSTITUENCIES

REGION NO. 1: KUNENE REGION comprising:

*Ruacana Constituency*

This Constituency is bounded on the north by the middle of the Kunene River from the said river's mouth upstream to the Ruacana Falls whence the boundary conforms with the demarcated international straight line eastwards to Boundary Beacon 5; thence the boundary turns southwards and coincides with the straight line boundary common to the Kunene and Omusati Regions as far as line of latitude 18°S; thence along this line of latitude westwards to the Atlantic Ocean; thence along the line of the coast in a general northerly direction to the mouth of the Kunene River.

*Opuwo Constituency*

This Constituency is bounded by line of latitude 18°S from the coast eastwards to the straight line boundary common to the Kunene and Omusati Regions; thence in a general southerly direction in a straight line to the north-western corner of the Etosha National Park as defined in Schedule 2 to the Nature Conservation Ordinance, 1975 (Ordinance 4 of 1975); thence along the western boundaries of the said Park in a general south-westerly direction to the intersection with line of latitude 19°S; thence along the last-mentioned line of latitude westwards to the coast; whence the line of the coast running in a general north-westerly direction to the point of beginning forms the boundary.

*Sesfontein Constituency*

This Constituency is bounded from the coast by line of latitude 19°S eastwards up to the western boundaries of the district of Outjo as defined in Government Notice 580 of 1973; thence along the boundaries of the said district in a general southerly direction to line of latitude 20°S; thence the last-mentioned line of latitude is followed westwards to the coast, which running in a general north-westerly direction then forms the boundary to the point of beginning.

*Khorixas Constituency*

This Constituency is bounded from the coast by line of latitude 20°S eastwards up to the western boundary of the district of Outjo as defined in Government Notice 580 of 1975; thence along the boundaries of the said district in a general south-easterly direction to the middle of the Ugab River; thence the middle of the Ugab River forms the southern boundary of the Constituency downstream to the said river's mouth; thence the line of the coast following a general north-westerly direction to the point of beginning forms the boundary.

*Kamanjab Constituency*

Beginning at the north-western corner of the Etosha National Park as defined in Schedule 2 to the Nature Conservation Ordinance, 1975 (Ordinance 4 of 1975) along the northern boundaries of the Park eastwards until line of longitude  $16^{\circ}$  E is reached; thence southwards along this line of longitude to the southern boundary of the said Park, thence westwards along the southern boundaries of the said Park to the north-eastern beacon of the farm Leeupoort 441; thence in a general southerly direction along the eastern boundaries of the following farms in succession so as to include these farms in the Constituency: Leeupoort 441, Excelsior 442, Vergenoeg 448, Afguns 447, Otjovasandu 183, Tzobaas 218, Tzaus 225, Aimab 124, Borwa 123, Luisental 114, Neuland 541, Dornfeld 135, Deurslag 136, Klein Omburo 148 and Iris 145; thence in general westerly, north-westerly and also northerly directions the boundaries of the Constituency coincide to the point of beginning with those of the district of Outjo as defined in Government Notice 580 of 1973.

*Outjo Constituency*

This Constituency consists of that part of the district of Outjo as defined in Government Notice 580 of 1973 which is not included in the Kamanjab Constituency together with that portion of the Etosha National Park which previously formed part of the Tsumeb Magisterial District.

## REGION NO. 2: OMUSATI REGION comprising:

*Onesi Constituency*

Beginning at Boundary Beacon 5 on the Namibia/Angola border, generally eastwards to the middle of the road entering Namibia from Calueque in Angola; thence along the middle of the said road south-eastwards to the Ruacana-Oshakati main road; thence in a general southerly direction along the middle of the road which passes east of Eunda and turns eastwards north of Onesi; thence at the point on this road where system 22/15 co-ordinate Y+30000 is reached, follow grid direction  $0^{\circ}$  to intersect the Onesi-Tsandi road; thence along the middle of the last-mentioned road in a general south-easterly direction to a T-junction at approximate co-ordinates Y+22400 and X-479250 on system 22/15; thence along the fork leading in a general westerly direction to the regional boundary common to the Kunene and Omusati Regions; thence northwards along the said boundary to the point of beginning.

*Tsandi Constituency*

Beginning at the south-western corner point of the Onesi Constituency and along the road in a general easterly direction to the road junction at system 22/15 approximate co-ordinates Y+22400 and X-479250; thence in a straight line at approximate grid direction  $261^{\circ}$  until the line intersects the middle of the Ombalantu-Ongandjera road at co-ordinate X-483500; thence

along the middle of the road in a general southerly direction to its intersection with the middle of the Etaka Oshana; thence along grid direction  $90^\circ$  to the middle of the Tsandi-Ongandjera district road; thence in a straight line in an approximate south-westerly direction to line of longitude  $15^\circ$  E at co-ordinate X-452000; thence southwards along the meridian to its intersection at approximate latitude  $18^\circ$  S with a road running in approximate grid direction  $63^\circ$  to the south-west; thence from the road south-west second from the point where the said road intersects the regional boundary common to the Kunene and Omusati Regions, northwards along the said boundary to the point of beginning.

#### *Uutapi Constituency*

Beginning at the point at which the middle of the road entering Namibia from Calueque in Angola crosses the Namibia/Angola border, along the said border eastwards up to line of longitude  $15^\circ$  E; thence southwards along the said line of longitude until it intersects the middle of the Oshakati-Ruacana main road; thence in a straight line at system 22/15 grid direction  $45^\circ$  for approximately two kilometres until a road running in a general southerly direction is intersected; thence southwards along the last-mentioned road for approximately four kilometres until a T-junction is reached; thence eastwards for approximately one kilometre, and along the road south-south-east until approximate co-ordinates Y-4500 and X-483500 on system 22/15 in the middle of an Oshana are attained (this point will be common with the Tsandi and Ogongo Constituencies); thence in a straight line at approximate grid direction on system 22/15 at  $81^\circ$  until the point with approximate co-ordinates Y+22400 and X-479250 on system 22/15 is reached (this point is common to the Onesi and Tsandi Constituencies); thence along the western boundaries of the Onesi Constituency in a general north-westerly direction to the point of beginning, so as to exclude the Onesi and Eunda Communities.

#### *Anamulenge Constituency*

Beginning at the point where line of longitude  $15^\circ$  E crosses the Namibia/Angola border, eastwards along the border approximately six kilometres to the point where an Oshana enters Namibia; thence in a general south-easterly direction along the middle of the said Oshana until it intersects at system 22/15 approximate co-ordinates Y-29000 and X-482700 the centre line of the Oshakati to Ruacana main road; thence along the centre line of the said road in a general north-westerly direction to approximate longitude  $15^\circ 01' E$  to a point where a road turns off to the south-west; thence along the said road for approximately three kilometres until the eastern boundary of the Uutapi Constituency is reached; thence along the eastern boundary of the said Constituency in a general north-westerly direction and on grid direction  $225^\circ$  to its intersection with the centre line of the Oshakati to Ruacana main road on the  $15^\circ$  E line of longitude; thence northwards along the said meridian to the point of beginning.

*Ogongo Constituency*

Beginning at the south-eastern corner of the Anamulenge Constituency, i.e. the intersection of the middle of an Oshana with the centre line of the Oshakati to Ruacana main road localised by system 22/15 approximate co-ordinates Y-29000 and X-482700; thence southwards and eastwards along the centre line of the said main road to co-ordinate Y-33500; thence in grid direction  $0^\circ$  to the middle of the Gwashuui Oshana; thence in a general south-easterly direction along the middle of the Oshana to its intersection with the Elim-Ongandjera district road; thence in a general west-south-westerly direction along the middle of the said road to the Etaka Oshana; thence in a general north-westerly direction along the middle of the said Oshana to the eastern boundary of the Tsandi Constituency; thence along the road in a general northerly direction along the eastern boundary of the Tsandi Constituency and part of the eastern boundary of the Uutapi Constituency to the boundary of the Anamulenge Constituency south of Nakayale; thence along the last-mentioned boundary for approximately three kilometres until the Oshakati-Ruacana main road is joined at approximate longitude  $15^\circ 01' E$ ; thence along the centre of the said road in a general south-easterly direction to the point of beginning.

*Okalongo Constituency*

Beginning at the point on the Namibia/Angola border approximately six kilometres east of the line of longitude  $15^\circ E$  where an Oshana enters Namibia, eastwards along the border until it intersects the Shakambebe Oshana; thence in a general southerly direction along the middle of the Oshana to a point with system 22/15 approximate co-ordinates Y-65000 and X-491700; thence in a straight line to the point with approximate co-ordinates Y-29000 and X-482700, being the south-eastern corner of the Anamulenge Constituency; thence in a general north-westerly direction along the middle of the Oshana to the point of beginning.

*Oshikuku Constituency*

Beginning at the south-eastern corner point of the Anamulenge Constituency with system 22/15 approximate co-ordinates Y-29000 and X-482700, eastwards in a straight line along the southern boundary of the Okalongo Constituency to the point where the Okalongo-Oshikuku road crosses the said boundary at approximate co-ordinate Y-48500; thence along the middle of the said road in a general southerly direction until it meets the Ruacana-Oshakati main road; thence proceed along the centre line of the said main road in a general easterly direction, so as to include Oshikuku in the Constituency, to a point with co-ordinate Y-54000; thence along grid direction  $45^\circ$  to intersect the Oshikuku-Elim district road; thence along the middle of the said district road in a southerly direction to a point with co-ordinate X-474000; thence along grid direction  $90^\circ$  to co-ordinate Y-49000; thence along grid direction  $0^\circ$  to intersect the Elim-Ongandjera district road so that Elim is excluded from this Constituency; thence in a general south-westerly direction along the middle of the said road to its intersection with the middle of the Gwashuui Oshana; thence to the point of

beginning along the eastern boundaries of the Ogongo Constituency so as to exclude Ogongo from the Oshikuku Constituency.

#### *Elim Constituency*

Beginning at the easternmost corner of the Okalongo Constituency localised by system 22/15 approximate co-ordinates Y-65000 and X-491700, along the middle of the Shakambebe Oshana southwards along the regional boundary to the corner point common to the Omusati, Oshana and Oshana Regions and which is localised by approximate co-ordinates Y-69500 and 479000; thence in an approximate south-westerly direction along the straight line regional boundary common to the Omusati and Oshana Regions to the Gwashuui Oshana; thence along the middle of the last-mentioned Oshana in a general northerly direction to the Ongandjera-Elim district road; thence in a general easterly and north-easterly direction along the middle of the said road to co-ordinate Y-49000; thence along grid direction  $180^\circ$  to co-ordinate X-47400; thence along grid direction  $270^\circ$  to intersect the Elim-Oshikuku district road; thence in a general northerly direction along the middle of the said road to the point where grid direction  $225^\circ$  intersects the centre line of the Oshakati-Ruacana main road at co-ordinate Y-54000; thence along the centre of the said main road in a general westerly direction to the point where the Oshikuku-Okalongo road turns off northwards (Oshikuku is thus excluded from this Constituency); thence along the middle of the last-mentioned road to its intersection with the straight line southern boundary of the Okalongo Constituency at approximate co-ordinate Y-48500; thence along the said boundary eastwards to the point of beginning.

#### *Okahao Constituency*

Beginning at the north-western corner point of the Etosha National Park as defined in Schedule 2 to the Nature Conservation Ordinance, 1975 (Ordinance 4 of 1975), northwards along the regional boundary common to the Kunene and Omusati Regions to the south-western corner of the Tsandi Constituency; thence in a general north-easterly direction along the boundaries of the said Constituency to the intersection of the Ongandjera-Ombalantu road with the Etaka Oshana; thence along the southern boundaries of the Ogongo Constituency to the Gwashuui Oshana, where a corner point common to this Constituency and the Ogongo, Oshikuku and Elim Constituencies is formed; thence in a general southerly direction along the middle of the said Oshana to the regional boundary common to the Omusati and Oshana Regions; thence along the said boundary to the northern boundary of the said Etosha National Park; thence in a general westerly direction along the northern boundaries of the said Park to the point of beginning.

REGION NO. 3: OSHANA REGION comprising:

#### *Oshakati Constituency*

Beginning at the beacon A on diagram A65/91 of the farm Oshakati Town and Townlands 880 and along boundaries A-B-C-D-E according to the said diagram so as to include the said farm in the Constituency; thence eastwards from the last-mentioned beacon along the southern boundary of adjoining

farm Ongwediva Town and Townlands 881 so as to exclude it from the Oshakati Constituency; thence from the point of intersection of the farm boundary with the centre line of the Oshakati to Ondangwa main road, along the centre line of the said main road south-eastwards until it is crossed by the Oshana which drains into the so-called Lake Oponono; thence in a general southerly direction along the middle of the said Oshana until grid line X-450000 on system 22/15 is intersected; thence westwards along the said grid line until the Uuvudhiya-Oshakati road is reached; thence along the middle of the last-mentioned road in a general north-easterly direction until it intersects the western boundary of the farm Oshakati Town and Townlands 880; thence along the boundary of the last-mentioned farm northwards to the point of beginning.

#### *Ongwediva Constituency*

Beginning at the beacon A on diagram A66/91 of the farm Ongwediva Town and Townlands 881 along boundary A-B eastwards until it is intersected by the Oshana which drains into the so-called Lake Oponono; thence along the middle of the Oshana in a general north-easterly direction until it meets the boundary common to the Oshana Region and the Ohangwena Region; thence eastwards along the regional boundary until it is crossed by the Endola-Ondangwa road; thence along the middle of the said road in a general south-easterly direction until it intersects the northern boundary of the farm Ondangwa Town and Townlands 882 which is represented by diagram A64/91; thence westwards along the farm boundary to the said beacon A; thence southwards along part of boundary A-D to the centre line of the Ondangwa-Oshakati main road so as to exclude the farm Ondangwa Town and Townlands 882 from the Ongwediva Constituency; thence along the middle of the said main road in a general north-westerly direction until the road intersects the boundary of the farm Ongwediva Town and Townlands 881; thence westwards and northwards along the farm boundaries to the point of beginning so as to exclude the farm Oshakati Town and Townlands 880 from the Ongwediva Constituency.

#### *Okaku Constituency*

Beginning at the point where the Endola-Ondangwa road crosses the boundary common to the Oshana and the Ohangwena Regions, eastwards along the regional boundary to a point with geographical co-ordinates latitude  $17^{\circ}41'20''S$  and longitude  $16^{\circ}E$ ; thence southwards in a straight line to the beacon lettered B on diagram A64/91 of the farm Ondangwa Town and Townlands 882; thence along the farm boundary from the said beacon westwards until it is intersected by the Ondangwa-Endola road, so as to exclude the said farm from the Okaku Constituency; thence along the middle of the said road in a general north-westerly direction to the point of beginning.

#### *Okatana Constituency*

Beginning at the point with approximate co-ordinates Y-69500 and X-479000 on system 22/15, eastwards in a straight line towards the point



with geographical co-ordinates latitude  $17^{\circ}41'20''S$  and longitude  $16^{\circ}E$  along the regional boundary common to the Oshana and Ohangwena Regions, up to the point where the Oshana which drains into the so-called Lake Oponono crosses the regional boundary; thence in a general south-westerly direction along the middle of the said Oshana to its intersection with the northern boundary of the farm Ongwediva Town and Townlands 881; thence westwards along the northern boundary of the said farm to the corner beacon common with the farm Oshakati Town and Townlands 880; thence northwards, westwards, south-westwards and southwards along the boundaries of the last-mentioned farm to the point where the Oshakati-Uuvudhiya road intersects the western boundary (both the farms 881 and 880 are thus in turn excluded from the Okatana Constituency); thence in a general south-westerly and southerly direction along the middle of the road until it crosses an Oshana at approximate latitude  $18^{\circ}00'30''S$ ; thence along the middle of the Oshana in a general north-westerly direction to the boundary common to the Omusati and Oshana Regions; thence along the straight line regional boundary in a general north-easterly direction to the point of beginning.

#### *Ondangwa Constituency*

Beginning at the point where the centre line of the Oshakati-Ondangwa main road crosses the western boundary of the farm Ondangwa Town and Townlands 882 northwards, eastwards and southwards along the boundaries of the said farm to the beacon C on diagram A64/91 of the said farm so as to include the farm in the Constituency; thence from the said beacon, due south along the regional boundary to a point with system 22/15 co-ordinate X-442500; thence westwards on grid direction  $90^{\circ}$  to the intersection with the middle of the Oshana draining southwards into the so-called Lake Oponono; thence in a general northerly direction along the middle of the said Oshana to the centre line of the Oshakati-Ondangwa main road; thence along the centre line of the said main road in a general easterly and south-easterly direction to the point of beginning.

#### *Ompundja Constituency*

Beginning at the south-western corner point of the Oshakati Constituency along the grid line with value X-450000 on system 22/15 at grid direction  $270^{\circ}$  to its intersection with the middle of the Oshana which drains in a general southerly direction into the so-called Lake Oponono; thence along the middle of the said Oshana southwards to the "lake" and thence upstream in a general north-westerly direction via the middle of the Oshana which emanates from the south-eastern corner point of the Okatana Constituency; thence from the said corner point in a general north-easterly direction along the middle of the Uuvudhiya-Oshakati road to the point of beginning.

#### *Uukwiyu Constituency*

Beginning at the south-western corner of the Ondangwa Constituency, i.e. at the point with value X-442500 on system 22/15 and in the middle of the Oshana which drains generally southwards to the so-called Lake Oponono;

thence eastwards at grid direction  $270^{\circ}$  in a straight line to the south-eastern corner of the Ondangwa Constituency; thence southwards along the regional boundary until the road junction at approximate latitude  $18^{\circ}01'S$  is reached; thence along the middle of the road in a general south-westerly direction to the middle of the Ekuma Oshana; thence along the middle of the said Oshana in a general north-westerly direction and through the "lake" area via the deepest channel to the mouth of the Oshana which enters the north-west corner of the "lake"; thence along the middle of the Oshana in a general northerly direction to the point of beginning.

#### *Okatjali Constituency*

Beginning at the T-junction of the roads forming a corner point of the Uukwiyu Constituency near latitude  $18^{\circ}01'S$  and longitude  $16^{\circ}E$  along the middle of the road for approximately two kilometres until it joins the north-south road from Olukonda; thence along the middle of the road in a general southerly direction until the co-ordinate value on system 22/15 of X-400000 is reached; thence westwards at grid direction  $90^{\circ}$  to the middle of the Ekuma Oshana; thence along the middle of the said Oshana in a general northerly direction to the southernmost corner point of the Uukwiyu Constituency; thence along the middle of the road in a general north-easterly direction to the point of beginning.

#### *Uuvudhiya Constituency*

Beginning at the southernmost corner point common to the Oshana and Omusati Regions on the northern boundary of the Etosha National Park as defined in Schedule 2 to the Nature Conservation Ordinance, 1975 (Ordinance 4 of 1975); thence in general northerly, north-westerly and north-easterly directions along the boundaries common to the said Regions to the westernmost corner point of the Okatana Constituency; thence in a clockwise direction from this point, the Constituency is bounded in succession by boundaries which are common with the Okatana Constituency, the Ompundja Constituency, the Uukwiyu Constituency and the Okatjali Constituency; thence at the middle of the Ekuma Oshana southwards to the northern boundary of the Etosha National Park; thence in a general westerly direction to the point of beginning along the northern boundaries of the said Park.

REGION NO. 4: OHANGWENA REGION comprising:

#### *Ongenga Constituency*

Beginning at the point on the Namibia/Angola border where it is intersected by the middle of the Shakambebe Oshana eastwards along the border to Boundary Beacon 19 which is situated approximately three kilometres west of the Oshikango Border Post; thence in a straight line in an approximate south-westerly direction to a point in the middle of the Shakambebe Oshana with approximate system 22/15 co-ordinates Y-65000 and X-491700; thence along the middle of the said Oshana in a general northerly direction to the point of beginning.

### *Engela Constituency*

Beginning at Boundary Beacon 19 on the Namibia/Angola border eastwards along the border to its intersection with Trunk Road 1 at Oshikango Border Post; thence along the centre line of the said trunk road southwards to system 22/15 co-ordinate X-502000; thence in grid direction  $90^\circ$  to co-ordinate Y-90000; thence along a straight line approximately south-westwards to the common regional corner point in the middle of the Shakambebe Oshana at approximate system 22/15 co-ordinates Y-69500 and X-479000; thence along the middle of the said Oshana in a general northerly direction to the point with approximate system 22/15 co-ordinates Y-65000 and X-491700; thence follow a straight line in an approximately north-easterly direction to the point of beginning.

### *Oshikango Constituency*

Beginning at the point on the Namibia/Angola border where it is intersected at the Oshikango Border Post by Trunk Road 1, eastwards along the said border to a point where it is joined by a road from the south-west at approximate system 22/17 co-ordinate Y+95500; thence along the middle of the last-mentioned road in a general south-westerly and southerly direction to co-ordinate X-497000; thence on grid direction  $90^\circ$  to co-ordinate Y+102500; thence on grid direction  $0^\circ$  to co-ordinate X-493500; thence along grid direction  $270^\circ$  to the middle of the Oshana which flows southwards through Ondobe; thence along the middle of the said Oshana in a general southerly direction to its confluence with the Gwashigambo; thence upstream in a general north-westerly direction along the middle of the Gwashigambo to system 22/15 co-ordinate X-496500; thence along grid direction  $127^\circ$  to its intersection with the centre line of Trunk Road 1; thence along the centre line of the said trunk road northwards back to the point of beginning.

### *Ondobe Constituency*

Beginning at the point where a road joins the Namibia/Angola border at system 22/17 approximate co-ordinate Y+95500 eastwards along the said border to a point with approximate co-ordinate Y+73000 where another road from the south joins the said border at nearly a right angle; thence along middle of the last-mentioned road southwards to co-ordinate X-502000; thence in grid direction  $90^\circ$  to co-ordinate Y+73500; thence in grid  $0^\circ$  to intersect the Eenhana-Ehoma road; thence along the middle of the road in a general south-westerly then southerly direction to system 22/17 co-ordinate X-476000; thence in grid direction  $45^\circ$  to intersect the regional boundary common to the Ohangwena and Oshikoto Regions; thence along the regional boundary approximately north-westwards to the point where it is crossed by the Gwashigambo Oshana; thence upstream along the middle of the said Oshana to the southernmost point of the Oshikango Constituency; thence along the middle of the tributary in a general northerly direction to system 22/17 co-ordinate X-493500; thence in grid direction  $90^\circ$  to co-ordinate Y+102500; thence in grid direction  $180^\circ$  to co-ordinate X-497000;

thence in grid direction  $270^\circ$  to intersect a south-north road, thence along the middle of the road in a general northerly then north-easterly direction to the point of beginning.

#### *Eenhana Constituency*

Beginning at the point where a road joins the Namibia/Angola border at system 22/17 approximate co-ordinate Y+73000 eastwards along the border to Boundary Beacon 26; thence in grid direction  $0^\circ$  to intersect the Eenhana-Okongo district road; thence eastwards along the middle of the said road to the turn-off south of Elundu of the road leading in a general southerly and south-westerly direction; thence along the middle of the last-mentioned road until it crosses the Ompako Oshana south of Ohamwimbi; thence along the middle of the said Oshana in a general south-south-westerly direction until it intersects the regional boundary common to the Ohangwena and Oshikoto Regions; thence along the regional boundary in an approximate north-westerly direction to the south-eastern corner of the Ondobe Constituency; thence along system 22/17 grid direction  $225^\circ$  to co-ordinate X-476000 in the middle of the road to Ehoma; thence in a general northerly then north-easterly direction along the middle of the said road to system 22/17 co-ordinate Y+73500; thence in grid direction  $180^\circ$  to co-ordinate X-502000; thence in grid direction  $270^\circ$  to intersect the road north of Eenhana; thence in a general northerly direction along the middle of the last-mentioned road to the point of beginning.

#### *Omundaungilo Constituency*

Beginning at Boundary Beacon 26 on the Namibia/Angola border eastwards to a point where a road from the south joins the said border at system 22/17 approximate co-ordinate Y+13300; thence along middle of the said road southwards to its intersection with the Okongo-Eenhana district road; thence along the middle of the said district road in an approximate west-south-westerly direction to the point where grid direction  $180^\circ$  will lead to the point of beginning and follow the said direction.

#### *Okongo Constituency*

Beginning at the point on the Namibia/Angola border where it is joined by a road from the south at system 22/17 approximate co-ordinate Y+13300; thence eastwards along the border to longitude  $18^\circ$  E; thence southwards along the meridian to latitude  $17^\circ 45' S$ ; thence along a straight line in grid direction  $89^\circ$  along the regional boundary common to the Ohangwena and Oshikoto Regions to its intersection with a south-north road at system 22/17 approximate co-ordinate Y+500; thence along the middle of the said road in a general north-north-westerly direction to the point of beginning.

#### *Ohangwena Constituency*

Beginning at the point with system 22/15 co-ordinates Y-90000 and X-502000 along grid direction  $270^\circ$  to its intersection with the centre line of

Trunk Road 1; thence northwards along the centre line of the said road to the point where it is intersected by grid direction 127° coming from co-ordinate X-496500 in the middle of the Gwashigambo Oshana; thence along grid direction 307° back to the aforesaid position in the middle of the said Oshana; thence in a general south-easterly direction along the middle of the said Oshana to co-ordinate X-491500; thence along grid direction 90° to its intersection with the straight line south-eastern boundary of the Engela Constituency; thence along the said boundary to the point of beginning.

#### *Endola Constituency*

Beginning at one of the two corner points common to the Omusati, Ohangwena and Oshana Regions — which is situated in the middle of the Shakambebe Oshana and is localised by system 22/15 approximate co-ordinates Y-69500 and X-479000, in an approximate north-easterly direction along the straight line south-eastern boundary of the Engela Constituency to co-ordinate X-491500; thence in grid direction 270° to the middle of the Gwashigambo Oshana; thence in a general south-easterly direction along the middle of the said Oshana until it intersects the regional boundary common to the Ohangwena and Oshikoto Regions; thence in an approximate north-westerly direction to the second common corner point of the three afore-mentioned regions and which is defined by geographical co-ordinates latitude 17°41'20"S and longitude 16°E; thence follow a straight line approximately westwards along the regional boundary common to the Ohangwena and Oshana Regions to the point of beginning.

#### *Epembe Constituency*

Beginning at the fork in the district roads south of Elundu in an approximate easterly direction along the middle of the district road to the south-eastern corner of the Omundaungilo Constituency; thence along the middle of the road which leads generally southwards to its intersection with the regional boundary common to the Ohangwena and Oshikoto Regions at system 22/17 approximate co-ordinate Y+500; thence along the said regional boundary in an approximate westerly, south-westerly and north-westerly direction until it is intersected by the Ompako Oshana; thence in a general north-easterly direction along the middle of the said Oshana until it meets the district road south of Ohamwimbi; thence along the middle of the last-mentioned road in a general north-easterly and northerly direction to the point of beginning.

### REGION NO. 5: OSHIKOTO REGION comprising:

#### *Oniipa Constituency*

Beginning at the point defined by geographical co-ordinates latitude 17°41'20"S and longitude 16°E in an approximate south-easterly direction for a distance of nineteen kilometres along the straight line regional boundary between the Ohangwena and Oshikoto Regions which leads towards the church at Okankolo; thence along a straight line in a general

south-south-westerly direction to the point where the middle of the Gwashigambo Oshana crosses the centre line of the Ondangwa-Tsumeb trunk road; thence along the centre line of the said trunk road in a general north-westerly direction to its intersection with the eastern boundary of the farm Ondangwa Town and Townlands 882 as represented by the line B-C on diagram A64/91; thence along the said farm boundary northwards to the beacon B so as to exclude farm Ondangwa Town and Townlands 882 from the Oniipa Constituency; thence generally northwards along the straight line regional boundary to the point of beginning.

#### *Onayena Constituency*

Beginning at the point on the regional boundary common to the Ohangwena and Oshikoto Regions nineteen kilometres away from and approximately south-east of the point defined by geographical co-ordinates latitude  $17^{\circ}41'20''S$  and longitude  $16^{\circ}E$  along a straight line towards the church at Okankolo until the Ompako Oshana crosses the said regional boundary; thence in approximate grid direction  $44^{\circ}$  in a straight line to the point where the Gwashigambo Oshana crosses a track at approximate system 22/17 co-ordinates of Y+95000 and X-421500; thence along the middle of the said Oshana in a general northerly direction to the centre line of the Ondangwa-Tsumeb trunk road; thence in a straight line in a general north-north-easterly direction to the point of beginning.

#### *Olukonda Constituency*

Beginning at the point where the Ondangwa-Tsumeb trunk road crosses the eastern boundary of farm Ondangwa Town and Townlands 882 along the centre line of the road in an approximate south-easterly direction to the point where it is intersected by the middle of the Gwashigambo Oshana; thence along the middle of the said Oshana in a general southern direction until it reaches a track at approximate system 22/17 co-ordinates Y+95000 and X-421500; thence in an approximate westerly direction along the middle of the track to the road which forms part of the regional boundary common to the Oshana and Oshikoto Regions; thence along the said regional boundary in a general northerly direction to the point of beginning.

#### *Omuntele Constituency*

Beginning at the point where the Ondangwa-Tsumeb trunk road crosses the south-eastern boundary of the Onayena Constituency along the centre line of the said road in an approximate south-easterly direction until its intersection with the middle of the Nipele Omuramba; thence along the middle of the said Omuramba in a general southerly direction to the northern boundary of the Etosha National Park, as defined in Schedule 2 to the Nature Conservation Ordinance, 1975 (Ordinance 4 of 1975); thence in a westerly direction along the boundary of the said Park to its intersection with the middle of the Ekuma Oshana; thence along the middle of the said Oshana in a general northerly direction until co-ordinate value on system 22/15 of X-400000 is reached; thence along grid direction  $270^{\circ}$  to the middle of the

road which forms part of the regional boundary between the Oshana and Oshikoto Regions; thence along the middle of the said road to the south-western corner of the Olukonda Constituency; thence eastwards and north-eastwards along the relevant boundaries of the Olukonda and Onayena Constituencies to the point of beginning.

#### *Okatope Constituency*

Beginning at the point on the regional boundary common to the Ohangwena and Oshikoto Regions where it is intersected by the middle of the Ompako Oshana approximately south-eastwards and then north-eastwards along the regional boundary until it is intersected by system 22/17 grid line Y+62500; thence in grid direction  $0^\circ$  to co-ordinate X-444500; thence in grid direction  $270^\circ$  to the middle of the road which leads in a general southerly direction from Okankolo and thereby excluding the community of Okankolo from the Okatope Constituency; thence along the middle of the said road in a general southerly direction until it meets a tributary of the Niipele at approximate system 22/17 co-ordinates Y+50000 and X-426000; thence downstream along the middle of the watercourse in a general south-westerly direction to its intersection with the centre line of the Tsumeb-Ondangwa trunk road; thence in an approximately north-westerly direction along the centre line of the said trunk road to its intersection with the south-eastern boundary of the Onayena Constituency; thence in a north-easterly direction along the said boundary to the point of beginning.

#### *Okankolo Constituency*

Beginning at the north-eastern corner of the Oshikoto Region with geographical co-ordinates latitude  $17^\circ 45'S$  and longitude  $18^\circ E$  southwards along the meridian until it is crossed by an east-west road at approximate latitude  $17^\circ 55'S$ ; thence along the middle of the said road in a general westerly direction past waterpoints Onalusheshete, Okengele and Ohaiyanda to the crossroads at system 22/17 approximate co-ordinates Y-6000 and X-453500; thence along the road which leads southwards until after approximately ten kilometres it is crossed by a tributary of the Niipele; thence along the middle of the tributary in a general westerly and south-westerly direction until it meets a road at system 22/17 approximate co-ordinates Y+50000 and X-426000; thence along the middle of the said road in a general northerly direction to co-ordinate value X-444500 on system 22/17; thence along grid direction  $90^\circ$  to co-ordinate Y+62500; thence along grid direction  $180^\circ$  until it intersects the Ohangwena-Oshikoto regional boundary; thence along the said regional boundary in east-north-east and easterly directions to the point of beginning.

#### *Omuthiyagwiipundi Constituency*

Beginning on the northern boundary of the Etosha National Park as defined in Schedule 2 to the Nature Conservation Ordinance, 1975 (Ordinance 4 of 1975), at the mouth of the Niipele Omuramba upstream along the middle of the said Omuramba in a general northerly direction; thence approximately two kilometres after crossing the Ondangwa to Tsumeb trunk road proceed

along the middle of a tributary entering the Nipele from the north-east; thence at system 22/17 approximate co-ordinates Y+50000 and X-426000, the said tributary is crossed by a road coming southwards from Okankolo —proceed in a general south-easterly direction along the middle of the road to its intersection with the centre line of the Ondangwa to Tsumeb trunk road; thence along the centre line of the said trunk road eastwards for approximately 2,5 kilometres until it is crossed by an Omuramba; thence in a general northerly direction along the middle of the said Omuramba for approximately seven kilometres and thereafter in a general easterly direction until a track is reached at system 22/17 approximate co-ordinates Y-52500 and X-404000; thence along the middle of the track in a southerly direction for approximately nine kilometres to the point where it is crossed by the Omuthiya Omuramba; thence along the middle of the last-mentioned Omuramba in a general westerly then south-westerly direction to the boundary of the said Etosha National Park; thence along the boundaries of the said Park in a general north-westerly and westerly direction to the point of beginning.

#### *Engodi Constituency*

Beginning at the easternmost corner of the Okatope Constituency, i.e. at the intersection of stream and road at system 22/17 approximate co-ordinates of Y+50000 and X-426000 along the southern boundaries of the Okankolo Constituency in general north-easterly, easterly, northerly and easterly directions to line of longitude 18°E; thence southwards along the said meridian to latitude 18°28'30"S; thence in a straight line in a general westerly direction to the beginning of the Omuthiya Omuramba; thence along the middle of the said Omuramba and continuing in a general westerly direction to the south-eastern corner of the Omuthiyagwiipundi Constituency; thence along the boundaries of the last-mentioned Constituency in a northerly, then general westerly, southerly and north-westerly direction to the point of beginning.

#### *Guinas Constituency*

This Constituency comprises that part of the district of Tsumeb, as defined in Government Notice 99 of 1977 but excluding the Oshikoto Constituency, and that part of the district which has now been included in the Outjo Constituency of the Kunene Region; but including that part of Owambo which is situated south of the relevant boundaries of the Omuthiyagwiipundi and Engodi Constituencies.

#### *Oshikoto Constituency*

Beginning at the south-westerly corner beacon of the Farm 477 in a general easterly direction along the southern boundaries of the Farms 477, 478, 100 and 480 to the south-eastern corner beacon of the last-mentioned farm, so as to exclude the said farms from the Oshikoto Constituency; thence in a general southerly direction from the north-western corner beacon of the Farm 658 along the western boundaries of the Farms 658, 661, 663 and 665 to the south-western corner beacon of the Farm 665 so as to exclude these farms



from the Oshikoto Constituency; thence in a general westerly direction along the northern boundaries of the farms Rooiplaas 772, Elandshoek 771 and Uithoek 770 to the north-western corner beacon of the last-mentioned farm so as to exclude these farms from the Oshikoto Constituency; thence in a straight line in an approximate northerly direction to the south-western corner beacon of the Farm 477, the point of beginning.

REGION NO. 6: OKAVANGO REGION comprising:

*Mpungu Constituency*

Beginning at the point where the Namibia/ Angola border is intersected by line of longitude 18° E eastwards along the said border until the middle of the Okavango River is reached; thence along the middle of the said river in a general south-easterly direction to a point at which a line in grid direction 90° meets the junction of the Rundu-Nkurenkuru main road with the road from Tsintsabis-Nkurenkuru; thence along the grid direction and from the said junction along the middle of the road leading generally south-westwards towards Tsintsabis until it meets line of longitude 18° E at approximate latitude 18° 32' S; thence northwards along the regional boundary to the point of beginning.

*Kahenge Constituency*

Beginning at the south-western corner of Area 1 of the district of Kavango, as defined in Schedule D to Government Notice 2428 of 1972 northwards along the 18th E meridian to the point at approximate latitude 18° 32' S where the road to Nkurenkuru leaves the regional boundary; thence along the middle of the said road to its junction with the Rundu-Nkurenkuru main road; thence in grid direction 270° — so as to exclude Nkurenkuru from the Kahenge Constituency — to the middle of the Okavango River; thence downstream along the middle of the said river to system 22/ 19 co-ordinate Y-29000; thence in approximate grid direction 3° in a generally straight line along lines cut through the bush to intersect the middle of the Rundu-Grootfontein trunk road approximately five kilometres south-west of the Trigsurvey Station Ru-Gr 3; thence along a straight line to the north-eastern corner beacon of the farm Wildhagen 1019; thence along the northern boundaries of the district of Grootfontein as defined in Schedule Q to Government Notice R.1148 of 1972 and part of the district of Tsumeb as defined in Government Notice 99 of 1977 to the point of beginning.

*Kapako Constituency*

Beginning at the point in the middle of the Okavango River (i.e. on the Namibia/ Angola border) at system 22/ 19 approximate co-ordinate Y-29000 along the middle of the said river downstream to a point at approximate co-ordinate Y-75000; thence in an approximate southerly direction in a straight line to a point in the middle of the Omatako Omuramba at approximate co-ordinate X-376500 in the general prolongation of a track coming from the west; thence along the middle of the said Omuramba in a

general southerly and south-westerly direction until it reaches the regional boundary common to the Okavango and Waterberg Regions; thence along the said regional boundary westwards and northwards to the north-eastern corner beacon of the farm Wildhagen 1019; thence along the eastern boundaries of the Kahenge Constituency in a general northerly direction to the point of beginning.

#### *Rundu Constituency*

Beginning at the point in the middle of the Okavango River at system 22/19 approximate co-ordinate Y-75000 generally eastwards downstream along the middle of the said river to a point at system 22/21 approximate co-ordinate Y+97000; thence approximately southwards in a straight line to a T-junction with the Rundu-Bagani road of a road from the south; thence generally southwards along the middle of the road until it intersects the Omatako Omuramba at approximate longitude  $20^{\circ}05'E$ ; thence along the middle of the said Omuramba upstream in a general south-westerly direction to approximate system 22/19 co-ordinate X-376500; thence in an approximate northerly direction in a straight line to the point of beginning.

#### *Mashari Constituency*

Beginning at a point in the middle of the Okavango River with system 22/21 approximate co-ordinate Y+97000 downstream in a general easterly direction along the middle of the said river to a point with approximate co-ordinate Y+74500 opposite a north-south cut line; thence southwards along the cutline and its prolongation to the regional boundary common to the Okavango and Waterberg Regions; thence westwards along the said boundary to its intersection with the Omatako Omuramba; thence generally north-eastwards along the middle of the said Omuramba to the middle of the road at approximate longitude  $20^{\circ}05'E$ ; thence northwards along the said road and across the Rundu-Bagani road to the point of beginning.

#### *Ndiyona Constituency*

Beginning at the point with system 22/21 approximate co-ordinate Y+74500 downstream in a general easterly direction along the middle of the Okavango River until its intersection with line of longitude  $21^{\circ}E$ ; thence along the meridian southwards to the "corner" in the Namibia/Botswana border and continue to latitude  $18^{\circ}15'$  until the east-west regional boundary common to the Okavango and Waterberg Regions is reached; thence along the said regional boundary westwards to the intersection with the cut line or its prolongation which forms the eastern boundary of the Mashari Constituency; thence along the said Constituency boundary northwards to the point of beginning.

**REGION NO. 7: CAPRIVI REGION** comprising:*Mukwe Constituency*

Beginning at the point where line of longitude 21° E intersects the middle of the Okavango River along the middle of the said river eastwards to Dikuyu Island; thence approximately eastwards along the straight line Namibia/Angola border to the middle of the Kwando River; thence along the middle of the said river in a general southerly direction until the Namibia/Botswana border is met; thence along the said border in general westerly direction to the 21° E meridian; thence northwards along the said meridian to the point of beginning.

*Kongola Constituency*

Beginning at the point where the Kwando River enters Namibia; thence approximately eastwards along the Namibia/Zambia straight line border to a point with system 22/25 co-ordinate Y+87000; thence along grid direction 341° 30' to meet the middle of the Katima Mulilo-Kongola road (universally known as the "Golden Highway"); thence along the middle of the said road in a general westerly direction until it crosses the middle of the Kwando River at Kongola Bridge; thence generally northwards along the middle of the said river to the point of beginning.

*Linyandi Constituency*

Beginning at the Kongola Bridge crossing of the Kwando River along the middle of the Kongola-Katima Mulilo road (the "Golden Highway") in a general eastwards direction to system 22/23 co-ordinate Y-83500; thence approximately south-eastwards in a straight line to a point in the middle of the Linyandi River at system 22/25 co-ordinate Y+95000, so as to include the Linyandi community in the Constituency; thence generally south-westwards, north-westwards and northwards along the middle of the Linyandi/Mashi River to the point of beginning.

*Sibinda Constituency*

Beginning at the point where the middle of the Katima Mulilo-Kongola road (the "Golden Highway") is intersected by system 22/25 grid direction 341° 30' coming from co-ordinate Y+87000 on the Namibia/Zambia border, along the said direction prolonged through the Liambezi Lake until it meets the Namibia/Botswana border; thence upstream along the middle of the Chobe/Linyandi River to the point with system 22/25 co-ordinate Y+95000; thence along the straight line Constituency boundary in an approximate north-westerly direction to the point in the middle of the "Golden Highway" at system 22/23 co-ordinate Y-83500; thence follow the middle of the said "Highway" to the point of beginning.

*Katima Mulilo Constituency*

Beginning at the point on the Namibia/Zambia border with system 22/25 co-ordinate Y+87000 and prolong the straight line boundary approximately eastwards to the middle of the main channel of the Zambezi River; thence along the middle of the said main channel downstream to a point with co-ordinates Y+71000 and X-499000; thence in an approximate south-easterly direction to a point with co-ordinate Y+24000 in the middle of the Chobe River following a straight line; thence upstream along the said river, i.e. along the Namibia/Botswana border, in a general south-westerly and then north-westerly direction to the point from which grid direction 161°30' is then followed to the point of beginning.

*Kabe Constituency*

This Constituency comprises that part of the Caprivi Region which is situated east of the Katima Mulilo Constituency.

## REGION NO. 8: ERONGO REGION comprising:

*Omaruru Constituency*

This Constituency comprises the district of Omaruru, as defined in Schedule N to Government Notice R.1148 of 1972.

*Karibib Constituency*

This Constituency comprises the district of Karibib, as defined in Schedule M to Government Notice R.1148 of 1972.

*Brandberg Constituency*

This Constituency comprises that part of the district of Damaraland, as defined in Schedule B to Government Notice 2428 of 1972 which lies south of the middle of the Ugab River less the area taken into the Arandis Constituency.

*Arandis Constituency*

This Constituency comprises the farm Arandis Townlands 170 and the area beginning at a point at the Nordring Street level crossing on the northern boundary of the Railway Reserve with system 22/15 co-ordinate Y+47975 in a straight line in an approximate northerly direction along Nordring Street to a point defined by co-ordinates Y+48128 and X+74070; thence in a series of straight lines between points in succession defined by co-ordinates Y+47861 and X+74020; Y+47639 and X+73828; Y+47440 and X+73723; Y+47285 and X+73378; Y+46813 and X+72990; thence from the last-quoted co-ordinates in a straight line to a point with co-ordinate Y+46405

on the northern boundary of the Township Mondesa Extension 3 as represented by General Plan G79; thence along the north-eastern boundary of the said Township and its prolongation to intersect the nearer boundary of the Railway Reserve; thence in a general south-westerly direction along the said boundary of the Railway Reserve back to the point of beginning.

#### *Swakopmund Constituency*

This Constituency comprises the district of Swakopmund, as defined in Government Notice 2425 of 1972 less that portion thereof situated north of the middle of the Ugab River; the portion taken up by the Mondesa Constituency; the portion taken up in Hardap Region, and part of the farm Arandis Townlands 170.

#### *Walvis Bay Constituency*

This Constituency comprises the district of Walvis Bay as defined in Government Notice 1667 of 1977.

### REGION NO. 9: OTJOZONDJUPA REGION comprising:

#### *Grootfontein Constituency*

Beginning at the south-eastern corner beacon of the farm Oktrooi 171 in a general north-westerly direction along the eastern boundaries of the following farms in succession so as to exclude these farms from the Constituency: Oktrooi 171, Gabasis 172, Hairabib II 173, Rooiwal 174, Hoffnung 175, Rietfontein 44, Farm 344, Awagosib 45, Block 648, and along the southern boundary of the farm Harasib 317 to the southernmost corner point of the district of Tsumeb as defined in Government Notice 99 of 1977, with the last-mentioned farm also excluded from the Grootfontein Constituency; thence along the boundaries common to the said district of Tsumeb and the district of Grootfontein, as defined in Schedule Q to Government Notice R.1148 of 1972, in a general northerly direction to the north-western corner beacon of the Farm 1059; thence eastwards and then southwards along the boundaries of the said district of Grootfontein to latitude 19° 15'S; thence eastwards along the northern boundary of the area called Bushmanland to the Namibia/Botswana border; thence southwards along the said border to its intersection with the middle of the Otjozondjou Omuramba — the middle of the Omuramba, or its northern arm where applicable, forms the boundary of the Grootfontein Constituency until the intersection with line of longitude 19° E is reached; thence in a northerly direction in a straight line to the southernmost corner beacon of the farm Klapperhof 960; thence along the boundaries of the said district of Grootfontein in a general north-westerly and then in a general south-westerly direction to the point of beginning.

*Otavi Constituency*

This Constituency comprises the district of Grootfontein as defined in Schedule Q to Government Notice R.1148 of 1972 less that part of the said district now falling in the limits of the Grootfontein Constituency.

*Okakarara Constituency*

This Constituency comprises the district of Hereroland West, as defined in Schedule B to Government Notice 1196 of 1970, less that part thereof which lies to the east of the straight line running southwards from the southernmost corner beacon of the farm Klapperhof 960 to the intersection of line of longitude 19°E with the middle of the northern arm of the Otjozondjou Omuramba.

*Otjiwarongo Constituency*

This Constituency comprises that part of the district of Otjiwarongo, as defined in Schedule O to Government Notice R.1148 of 1972, situated north-west of the Kranzberg-Tsumeb railway line including the Town of Otjiwarongo and Otjiwarongo Townlands South 308 and the Town of Kalkfeld and the Peri-Urban area as per Proclamation 11 of 1978.

*Okahandja Constituency*

Beginning at the point where Trunk Road I meets the southern boundary of the district of Otjiwarongo as defined in Schedule O to Government Notice R.1148 of 1972, in a general southerly direction along the middle of the said trunk road until it intersects the southern boundary of the district of Okahandja as defined in Schedule L to Government Notice R.1148 of 1972, but including Okahandja Consolidated Townlands 277; thence at the intersection of the southern boundary of the said district of Okahandja generally westwards, then generally northwards and eastwards along the boundaries of the said district of Okahandja to the point of beginning.

*Omatako Constituency*

This Constituency comprises that portion of the district of Otjiwarongo as defined in Schedule O to Government Notice R.1148 of 1972 which lies south-east of the Kranzberg-Tsumeb railway line excluding the Town of Otjiwarongo and Otjiwarongo Townlands 308 and the Town of Kalkfeld and the Peri-Urban area as per Proclamation 11 of 1978; and that part of the district of Okahandja as defined in Schedule L to Government Notice R.1148 of 1972 which falls outside the Okahandja Constituency.

**REGION NO. 10: OMAHEKE REGION** comprising:*Otjinene Constituency*

Beginning at the point at which the Otjozondjou Omuramba crosses the northern boundary of the district of Gobabis as defined in Government Notice 313 of 1976, in a general north-easterly and easterly direction along the middle of the northern arm of the said Omuramba until it is intersected by line of longitude 20° E; thence southwards in a straight line to the north-eastern corner beacon of the Farm 434 in the said district of Gobabis; thence in a general westerly, northerly and westerly direction along the boundaries of the said district of Gobabis to the point of beginning.

*Otjozondjou Constituency*

Beginning at the point where line of longitude 20° E intersects the northern arm of the Otjozondjou Omuramba, in a general easterly direction along the middle of the said Omuramba up to the Namibia/Botswana border at the line of longitude 21° E; thence southwards along this meridian to latitude 22° S; thence where the said border turns westwards along the line of latitude 22° S to longitude 20° E; thence at latitude 22° S and longitude 21° E northwards along the boundary of the district of Gobabis as defined in Government Notice 313 of 1976, up to the north-eastern corner beacon of the Farm 434 in the said district of Gobabis; thence northwards in a straight line to the point of beginning.

*Steinhausen Constituency*

Beginning at the northernmost beacon of the farm Lindenhof 205 in a general northerly direction along the boundaries of the district of Gobabis as defined in Government Notice 313 of 1976 common in turn with the district of Windhoek as defined in Schedule I to Government Notice R.1148 of 1972 before the amendment of the boundaries of the district by Government Notice 22 of 1989, and the district of Okahandja as defined in Schedule L to Government Notice R.1148 of 1972 up to the boundary of the said district of Hereroland West as defined in Schedule B to Government Notice 1196 of 1970; thence generally eastwards and southwards along the boundary of the said district of Gobabis common to Hereroland West and Area I of the district of Hereroland East, as defined in Schedule E to Government Notice 2428 of 1972, up to the south-eastern corner of the Farm 447 in the said district of Gobabis; thence generally westwards along the relevant boundaries of the following farms in succession so as to include them in the Constituency: Farm 447, Alkmar 512, Farm 511, Volstruiswerf 513, Klipkrans 974, Saambou 977, Witbank 443, Farm 435, Farm 427, Sukes 426, Helm 423, Haai 422, Owingi 246, Fleur 827, Farm 379, Farm 184, Libyan 341, Turfan 340, Farm 339, Mpunzi 278, Farm 277, Farm 276, Farm 570, Farm 212, Okanjesu 211 and Farm 515, to the point of beginning.

### *Gobabis Constituency*

Beginning at the northernmost corner beacon of the farm Lindenhof 205 so as to include it in the Gobabis Constituency, in a general easterly direction along the boundaries of the Steinhausen Constituency to the north-eastern corner beacon of the farm Elim 724, thence in a general southerly direction along the relevant boundaries of the following farms so as to include them in the Gobabis Constituency: Elim 724, Harem 382, Eava 383, Downen 384, Otjimukandi 178, Okahao 177, Farm 176, Farm 175, Farm 170, Townlands of Gobabis 114, Kakus 73, Karossewie 72, Nabatsaub 71, Spatzenfeld 70, Kaitzaub 68, Farm 59, Kuduberg 60, Tahiti 61, Auros 62, Louis Botha 63, Smuts 64, Aais 131, Aais 30 and thence westwards so as to include the following farms in the Gobabis Constituency: Aais 30, Kansas 34, and Wyoming 36; thence in a general northerly direction along the common boundaries of the districts of Windhoek and Gobabis as defined in Schedule I to Government Notice R.1148 of 1972 and Government Notice 313 of 1976, respectively, to the point of beginning.

### *Buitepos Constituency*

Beginning at the north-eastern corner beacon of the farm Elim 724 generally eastwards along the southern boundary of the Steinhausen Constituency to the south-eastern corner beacon of the Farm 447; thence southwards in a straight line to the elbow of the international border between Namibia and Botswana at 22°S latitude / 20°E longitude; thence southwards along the 20th meridian to latitude 23°S; thence westwards along the relevant borders of the following farms so as to include them in the Buitepos Constituency: Soronto 734, Nui-Sie 376, Farm 375, Goreb 374, Nuiba 373, Elsdale 372, Kentucky 371, Masindi 370, Semliki 369, Farm 492, Rosendal 496, Panda 495, Ruby 494, Anaheib 493, Farm 525, Farm 526, Claudius 527; thence from the south-western corner beacon of the last-mentioned farm, the boundary runs in a general northerly direction, coinciding with the eastern boundaries of the Gobabis Constituency, to the point of beginning.

### *Aminuis Constituency*

This Constituency comprises:

- (a) That part of the district of Gobabis as defined in Government Notice 313 of 1976, which has not been taken up in the Steinhausen, Gobabis and Buitepos Constituencies;
- (b) Areas 2 and 3 of the district of Hereroland East as defined in Government Notice 322 of 1976.



REGION NO. 11: KHOMAS REGION comprising:

*Wanaheda Constituency*

This Constituency comprises the Townships of Goreangab, Wanaheda, Wanaheda Extension 2, Wanaheda Extension 4, Wanaheda Extension 5, Wanaheda Extension 6, Wanaheda Extension 7 plus the Remainder of the farm Gammams 36 and subdivisions.

*Hakahana Constituency*

This Constituency comprises the Townships Wanaheda Extension 3, Wanaheda Extension 8, Hakahana, Okuryangava, Okuryangava Extension 1, Okuryangava Extension 2, Okuryangava Extension 3, Okuryangava Extension 4, Okuryangava Extension 5 and Lafrenz, the Remainder of the farm Nubuamis 37 and subdivisions, the Remainder of the farm Ongava 452 and subdivisions and the Remainder of the farm Ujams 288 and subdivisions.

*Katutura East Constituency*

This Constituency comprises the Townships Katutura, Katutura Extension 1, Katutura Extension 6 and Katutura Extension 19.

*Katutura Central Constituency*

This Constituency comprises the Townships Katutura Extension 2, Katutura Extension 3, Katutura Extension 4, Katutura Extension 5, Katutura Extension 7, Katutura Extension 8, Katutura Extension 9, Katutura Extension 10 and Katutura Extension 11.

*Soweto Constituency*

This Constituency comprises the Townships of Katutura Extension 12, Katutura Extension 13, Katutura Extension 14, Katutura Extension 16, Katutura Extension 18, Katutura Extension 20 and Erven 7084-6 Katutura.

*Khomasdal North Constituency*

The Constituency comprises the Townships Wanaheda Extension 1, Katutura Extension 15, Katutura Extension 17, Khomasdal, Khomasdal Extension 1, Khomasdal Extension 3, Khomasdal Extension 8, Khomasdal Extension 9, Khomasdal Extension 10, Khomasdal Extension 11, Khomasdal Extension 12, Khomasdal Extension 13, Khomasdal Extension 14, Khomasdal Extension 15, Haloid, Otjomuise, Portion 22 of the farm Katutura 390, Portion 96 of the farm Windhoek Town and Townlands 31, and an area bounded (in a clockwise direction) on the west by the Townships

Khomasdal, Khomasdal Extension 1, Khomasdal Extension 2, Katutura Extension 17 as far as Independence Avenue, on the north-east by the centre line of Independence Avenue, on the east by the centre line of the Western Freeway, and on the south by Florence Nightingale Street as far as Rand Street.

#### *Windhoek West Constituency*

Beginning at the point where the centre line of Independence Avenue crosses the centre line of the Western Freeway, in an approximate south-easterly and southerly direction along the former to its intersection with the middle of Bahnhof Street; thence westwards along the middle of Bahnhof Street to its intersection with the middle of Tal Street; thence southwards along the middle of Tal Street to the point where Republic Road diverges from Tal Street; thence along the centre line of Republic Road in a general southerly direction to the Auas Road and the Gamsberg Road fork; thence along centre line of Auas Road prolonged as Trunk Road 1 still in a general southerly direction until it meets the municipal boundary; thence along the boundaries of the Remainder of Portion B of the farm Windhoek Town and Townlands 31 in a north-westerly, westerly, north-westerly and north-easterly direction to the point of beginning but excluding the Khomasdal North Constituency.

#### *Windhoek East Constituency*

Beginning at the point where Klein Windhoek Road leaves Independence Avenue along the middle of the first-mentioned road in an easterly and then south-easterly direction to Kuiseb Street; thence along the middle of the latter in general north-easterly, easterly and southerly directions to its intersection with the boundary P'O' of General Plan K 171; thence from the intersection along the line southwards along the western boundary of Erf 94 Eros Park to O' and thereafter along the rear (i.e. eastern) boundaries of the erven in a general northerly direction as far as the northern boundary of the Remainder of Portion B of the farm Klein Windhoek Town and Townlands 70; thence in general easterly, southerly and westerly directions to the south-western corner beacon of the said farm; thence continue approximately south-westwards along the boundaries of the adjoining property Remainder of Portion B of the farm Windhoek Town and Townlands 31 to intersect Trunk Road 1; thence in a general northerly direction along the centre lines of the said trunk road, Auas Road, Republic Road and Tal Street to the intersection with Bahnhof Street; thence in an easterly direction along the middle of the last-mentioned street to Independence Avenue; thence northwards to the point of beginning along the middle of Independence Avenue.

#### *Windhoek Rural Constituency*

This Constituency comprises the Khomas Region as defined excluding the Constituencies Wanaheda, Hakahana, Katutura East, Katutura Central, Soweto, Khomasdal North, Windhoek West and Windhoek East.

**REGION NO. 12: HARDAP REGION** comprising:*Rehoboth West Urban Constituency*

This Constituency comprises Blocks A, B and F of the Rehoboth Town Area, plus that part of the farm Rehoboth Townlands 302 lying west of Trunk Road 1, and properties lying within the boundary of the Farm 302.

*Rehoboth East Urban Constituency*

This Constituency comprises Blocks B, C and E of the Rehoboth Town Area, plus that part of the farm Rehoboth Townlands 302 lying east of Trunk Road 1, and properties lying within the boundary of Farm 302.

*Rehoboth Rural Constituency*

This Constituency comprises the district of Rehoboth, as defined in Schedule G to Government Notice R.1148 of 1972 before the amendment of the boundaries of the said district by Official Notice 92 of 1989 of the former Government of Rehoboth, but excluding -

- (a) that part of the said district referred to in paragraph (b) of the definition of REGION NO. 11: KHOMAS REGION in Proclamation 6 of 1992.
- (b) Blocks A, B, C, D, E and F of the Rehoboth Town Area; and the Remainder of the farm Rehoboth Townlands 302 and properties falling within its outer limits.

*Mariental Rural Constituency*

This Constituency comprises that part of the district of Mariental as defined in Schedule F to Government Notice R.1148 of 1972 before the amendment of the boundaries of the said district by Government Notice 22 of 1989, which lies to the east of Trunk Road B1, but excluding the municipal area of Mariental and that part of Namaland falling into this area (north-eastern part of Namaland), which lies to the east of Trunk Road B1.

*Mariental Urban Constituency*

This Constituency comprises the Municipal Area of Mariental plus that part of the district of Mariental, as defined in Schedule F to Government Notice R.1148 of 1972 before the amendment of the boundaries of the said district by Government Notice 22 of 1989, which lies to the west of Trunk Road 1 but with the exclusion of that part of Namaland which is included in the Gibeon Constituency.

### *Gibeon Constituency*

This Constituency comprises the whole of the district of Maltahöhe, as defined in Schedule E to Government Notice R.1148 of 1972 before the amendment of the boundaries of the said district by Government Notice 22 of 1989; that part of the district of Swakopmund referred to in paragraph (a) of the definition of REGION NO. 12: HARDAP REGION in Proclamation 6 of 1992, and the off-shore island commonly known as Hollandsbird Island; and that part of Namaland which falls within the district of Mariental as defined in Schedule F to Government Notice R.1148 of 1972 before the amendment of the boundaries of the said district by Government Notice 22 of 1989.

REGION NO. 13: KARAS REGION comprising:

### *Keetmanshoop Urban Constituency*

This Constituency comprises the Municipal Area of Keetmanshoop excluding the township of Krönlein.

### *Berseba Constituency*

This Constituency comprises the whole of the district of Bethanie, as defined in Schedule C to Government Notice R.1148 of 1972 plus such part of Namaland as was formerly situated within the district of Keetmanshoop as defined in Schedule B to Government Notice R.1148 of 1972.

### *Lüderitz Constituency*

This Constituency comprises the district of Lüderitz as defined in Schedule D to Government Notice R.1148 of 1972 plus the off-shore islands of Namibia situated between parallel of latitude 25° south and the mouth of the Orange River, less the Oranjemund Constituency as defined.

### *Oranjemund Constituency*

Beginning at the easternmost beacon of the farm Zebrafontein 87 in an anti-clockwise direction along the boundaries of the farms Zebrafontein 87 and Trekpoort 96 so as to exclude these farms from the Oranjemund Constituency, until the point is reached where the track shown by small red dots on the 1979 map crosses the western boundary of the last-mentioned farm; thence along the track in a general southerly direction and along the southern fork until it joins the main Lüderitz-Oranjemund road; thence along the road southwards to its junction with the secondary road running westwards; thence along the said secondary road and its prolongation in a straight line to a point on the coast line; thence along the limits of the district of Lüderitz as defined in Schedule D to Government Notice R.1148 of 1972 in an anti-clockwise direction to the point of beginning, including the northern half of the bed of the Orange River from its mouth to its confluence with the Fish River.

*Karasburg Constituency*

This Constituency comprises the district of Karasburg, as defined in Schedule A to Government Notice R.1148 of 1972 and includes the northern half of the bed of the Orange River from line of longitude 20°E to the confluence with the Fish River.

*Keetmanshoop Rural Constituency*

This Constituency comprises the Township of Krönlein and the district of Keetmanshoop as defined in Schedule B to Government Notice R.1148 of 1972 but excludes the remaining part of the Municipal Area of Keetmanshoop and that part of Namaland which has been allotted to the Berseba Constituency.
