

REGULATIONS

1. Title - These Regulations may be cited as the Electoral Regulations 1991
2. Interpretation - In these Regulations unless the context otherwise requires -
  - "Act" means the Electoral Act 1963;
  - "Bed patient" means a patient who is qualified to vote and who by reason of his age, infirmity, ill health, or other like cause is unable to leave his bed on polling day to attend at a voting booth; or in respect of whom it could be injurious to his health to leave his bed on polling day to attend at a polling booth;
  - "Fixed Booth" means a polling booth in a hospital which is not a ward booth;
  - "Hospital" includes an institution for the care of the elderly;
  - "Issuing Officer" means any person authorised to issue ballot papers to special voters;
  - "Patient" means a person who by reason of age, infirmity, ill health, or other like cause is an inmate of a hospital during all or any part of a polling day;

"Polling place" means a building or part of a building in which facilities for voting are established;

"Registrar" means the Registrar of Electors and Voters appointed under the Act;

"Special Vote" means a vote of the kind provided for in regulations 4 and 5 of these regulations;

"Special voter" means a person, whether a voter or elector who is entitled to vote by way of special vote;

"Ward booth" has the meaning given to it by regulation 22 of these regulations.

**3. Lists of Candidates** - (1) The Chief Returning Officer shall forthwith after nomination day for any general election cause to be printed lists of candidates for every constituency setting out the names of the candidates.

(2) Sufficient copies of the lists so printed shall be sent to each Returning Officer to enable each Returning Officer to supply a copy to every person authorised to issue ballot papers to special voters.

**4. Facilities for special voting** - (1) In the case of a General Election, the Chief Returning Officer shall designate at every Polling Place at least one Returning Officer or Deputy Returning Officer to be an Issuing Officer for that polling place and ballot papers may be issued to special voters by those Issuing Officers.

(2) In the case of a By-election in any constituency the Chief Returning Officer may during the hours of polling maintain outside the constituency one or more offices for the issue and receipt by Deputy Returning officers of special votes.

**5. Voting by way of special vote** - (1) A special vote may be cast by an elector who is absent on polling day from the constituency in which he is enroled or by an elector or voter who is in possession of a certificate of identity if his name has been wrongly removed or omitted from the roll.

(2) Where an elector or voter wishes to vote by way of special vote he shall obtain from and complete in the presence of an Issuing Officer a statement in form B in the Schedule to these Regulations and after the same is completed it shall be witnessed by the Issuing Officer and retained by him.

(3) The Issuing Officer may assist an elector or voter to complete the form referred to in subclause (2) of this regulation.

(4) An application for a special vote shall be made in person by the elector or voter.

**6. Issue of special votes** - (1) Subject to regulation 4 of these regulations, any Issuing Officer may, upon application made by a special voter in accordance with regulation 5 of these regulations, issue a special ballot paper in form A in the Schedule to these regulations.

(2) The Issuing Officer shall (except where in the case of a by-election the names are preprinted on the ballot paper) insert in the ballot paper the names of the candidates as shown in the list supplied by the Chief Returning Officer.

(3) The Issuing Officer shall insert in the ballot paper the name of the constituency or roll in respect of which the vote is to be exercised and shall complete the Directions to Voter by inserting the number of candidates for whom the special voter is entitled to vote.

(4) Every person issuing a ballot paper in accordance with subclause (1) of this regulation -

- (a) Shall keep a document (herein referred to as a list of special voters) on which that person shall enter in consecutive order the consecutive number printed on each special ballot paper issued by that person and against that number the certificate of identity number and name of the special voter and the name of the electoral district or roll for which the vote was issued; and
- (b) Shall issue together with the ballot paper an envelope which contains 2 self-

contained compartments; the envelope shall be addressed to the Chief Returning Officer and the compartments shall be respectively marked "Statement" and "Ballot Paper".

(c) Shall clearly mark on the envelope the constituency or roll to which the statement relates and the serial number appearing on the statement.

(5) Where the name of a person wishing to vote is not on a main roll or any supplementary roll but that person produces a certificate of identity showing that he is an elector of a constituency, or an individual voter the Issuing Officer shall endorse on the statement the words "Not on printed roll- Certificate of Identity No.(state number) produced".

(6) Ballot papers issued under this regulation shall be printed without counterfoils, but a statement in Form B shall be attached to each ballot paper as if it were a counterfoil and such statement shall be printed with the same consecutive number as the ballot paper to which it is attached.

(7) The Issuing Officer shall, forthwith after entering the particulars required on the list of special voters referred to in subclause (4)(a) of this regulation, -

(a) Firmly fix a piece of gummed paper over the consecutive number on the ballot paper so as to conceal it effectively; and

(b) Place the Issuing Officer's official mark on the ballot paper and on the statement in form B.

**7. Voting by special voter** - (1) The vote of a person voting as a special voter shall be exercised in the manner prescribed by this regulation.

(2) The Issuing Officer shall, after the completion of the statement in form B, place the statement in the compartment of the envelope marked "Statement", which, after being sealed, shall be handed to the special voter together with the ballot paper.

(3) When the statement has been dealt with as required by subclause (2) of this regulation, the special voter shall then alone and secretly mark the ballot paper with a cross within the square immediately after the name of the candidate (or, where appropriate, candidates) for whom the special voter wishes to vote.

(4) The ballot paper shall then be placed in the compartment of the envelope marked "Ballot paper" and the compartment sealed by the special voter.

(5) The envelope shall be deposited as a Deputy Returning Officer directs or in a receptacle specially provided for the votes of special votes, and every such envelope shall be deemed to have been received by the Deputy Returning Officer at that booth at the time when it was so deposited.

(6) If the special voter is wholly or partially blind, or (whether because of physical handicap or otherwise) is unable to read or write or has severe difficulty in reading or writing, or is not sufficiently familiar with the Samoan or English language to vote without assistance, or because of illness or handicap is unable to vote without assistance, he may vote in accordance with the provisions of section 73 of the Act with the necessary modifications.

**8. Duty of persons present when vote exercised** - Every person present when a special voter is exercising a special vote -

(a) Shall comply with the foregoing provisions of these regulations in so far as they relate to him; and

(b) Shall, except as provided in regulation 7(6) of these regulations, refrain from looking at or making himself acquainted with the vote given by the special voter, and shall not in any way attempt to influence or interfere with the special voter in the exercise of his vote or allow any person to see or become acquainted with the vote or to assist the special voter to vote or to interfere in any way with the special voter in relation to his vote.

**9. Endorsement of envelopes** - Every envelope containing a special vote received by a Returning Officer or Deputy Returning Officer shall be marked with his official mark.

**10. Delivery of special votes to Chief Returning Officer** - (1) Every Issuing Officer shall immediately after the close of the poll, deliver to the Chief Returning Officer every envelope which appears to contain a special vote together with the list of special voters kept by him under regulation 6(4)(a) of these regulations:

Provided that an Issuing Officer if a Deputy Returning Officer, may deliver the envelope and list to the Returning Officer for the constituency in which his booth is located, in which case the Returning Officer shall immediately deliver the envelope to the Chief Returning Officer.

(2) If the Issuing Officer has not issued any special votes he shall, before complying with subclause (1) of this regulation, mark his list of special voters with the words "no special votes issued".

**11. Chief Returning Officer to extract statement** - At the first opportunity, the Chief Returning Officer shall open the statement compartment of the envelope and extract therefrom the statement.

**12. Statement enclosed in ballot paper compartment** - (1) Notwithstanding anything in these regulations, if the Chief Returning Officer has reason to believe that the statement in respect of any special vote is enclosed in the ballot compartment of the envelope containing the ballot paper, the Chief Returning Officer may open that compartment and extract the statement.

(2) In every such case the Chief Returning Officer shall immediately reseal the compartment containing the ballot paper and shall do everything possible to preserve the secrecy of the ballot. Upon resealing the compartment the Returning Officer shall endorse on it the words "Opened pursuant to regulation 12", and shall sign the endorsement.

**13. Chief Returning Officer to check rolls** - (1) The Chief Returning Officer shall examine each statement in respect of a special vote for the purpose of ascertaining whether the name specified in the statement appears on the main roll or any supplementary roll for the constituency in respect of which the vote has been exercised, or as the case may be on the main or supplementary individual voters roll.

(2) If the name specified in the statement appears on the main roll or any supplementary roll for the district, or as the case may be on the individual voters Roll the Returning Officer shall endorse the word "Qualified" on the statement.

(3) If the name specified in the statement does not appear on the main roll or any supplementary roll for the district, or on the individual voters roll the Chief Returning Officer shall, subject to subclause (4) of this regulation, forward the statement, at the first opportunity, to the Registrar.

(4) Nothing in subclause (3) of this regulation requires the Chief Returning Officer to forward a statement in accordance with that subclause if the Chief Returning Officer believes that, even if the person specified in the statement were qualified to vote, the vote would be disallowed on grounds other than the person's qualification to vote.

**14. Duties of Registrar**. - (1) Where a statement is forwarded to the Registrar under regulation 13(3) of these regulations, the Registrar shall ascertain whether in accordance with the information available to him the name specified in the statement is that of a person who is, in accordance with the Act, qualified to vote in the constituency in respect of which the vote was cast, or as the case may be qualified to vote as a special voter.

(2) The Registrar shall take into account, and may accept as sufficient evidence that the name specified on the statement is that of a person qualified to vote, any endorsement made, pursuant to regulation 6(4) of these regulations, on the statement.

(3) If the Registrar is satisfied that the name specified in the statement is that of a person qualified to vote as provided in subclause (1) of this regulation, the Registrar shall endorse the word "Qualified" on the statement, and shall then return it to the Chief Returning Officer.

(4) If the Registrar is not satisfied that the name specified in the statement is that

of a person qualified to vote, as provided in subclause (1) of this regulation, the Registrar shall endorse the words "Not qualified" on statement, and shall then return it to the Chief Returning Officer.

**15. Allowance or disallowance of votes -** (1) Where the words "Not qualified" have been endorsed, pursuant to regulation 14(4) of these regulations, on a statement, the Returning Officer shall disallow the vote of the elector specified in the statement.

(2) Where a statement has, pursuant to regulation 13(2) or regulation 14(3) of these regulations been endorsed with the word "Qualified", the Returning Officer shall allow the vote of the elector named unless the Returning Officer is required to disallow the vote in accordance with the Act or any other provision of these regulations.

(3) A special vote shall not be invalid by reason only of the fact that

- (a) it was exercised in the mistaken belief that the name of the special voter did not appear on the main or supplementary roll, when in fact it did so appear; or
- (b) the Statement in Form B has been completed in an incorrect manner, if it is sufficiently correctly completed as to satisfy the Registrar that the elector or voter was entitled to vote by way of special vote in the constituency for which the ballot paper was issued, or as the case may be, as an Individual Voter.

**16. Procedure where vote allowed -** (1) Where the Chief Returning Officer allows a vote under regulation 15 of these regulations, he shall identify the envelope with the statement and shall then place the envelope in a box specially set aside for the purpose.

(2) That box shall be a box that can be securely closed.

**17. Statements to be held by Chief Returning Officer for scrutiny -** The Chief Returning Officer shall hold for production at the scrutiny of the rolls under section 77 of the Act all statements returned to the Returning Officer under regulation 14 of these regulations together with those retained by the Returning Officer under regulation 12 of these regulations.

**18. Ballot papers issued to Special Voters to be included in scrutiny of rolls -** (1) The Chief Returning Officer in the presence of such scrutineers as choose to be present, on an unmarked copy of the main or supplementary roll for each constituency, and on the individual voters roll shall subject to subclause (3) of this regulation cause to be drawn a line through the number and name of every qualified special voter to whom a special voting paper has been issued.

(2) The Chief Returning Officer may comply with subclause (1) of this regulation at the time he checks the rolls in accordance with regulation 13 of these regulations and upon receipt of a statement marked "qualified" pursuant to regulation 15 of these regulations.

(3) Where any special vote is allowed pursuant to Regulation 14 of these regulations and the name of the elector casting that vote does not appear on any roll the Chief Returning Officer shall record that fact on the supplementary roll of the constituency in respect of which that vote has been allowed, or on the individual voters roll as the case may be, and section 77 of the Act shall apply to that person and his vote as if his name appeared on that roll.

(4) After The Chief Returning Officer has complied with subclause (1) of this regulation he shall mark each such main and supplementary roll with the words "Special Votes Roll" and shall on the face of such roll certify to the correctness thereof.

(5) Each certified Special Votes Roll shall be held by the Chief Returning Officer and shall be included by him in the comparison of the rolls required by section 77 of the Act and shall thereafter be dealt with according to the Act.

**19. Parcels of forms and envelopes -** After the scrutiny of the rolls, the Returning Officer shall make up into separate parcels -

- (a) All statements in form B:

- (b) All disallowed envelopes in respect of which the compartment containing the ballot paper has not been opened.

**20. Opening of envelopes containing votes allowed** - Subject to regulation 12 of these regulations, the ballot paper compartments of the envelopes placed, in accordance with regulation 16 of these regulations, in boxes that can be securely closed shall not be opened until the official count conducted under section 79 of the Act, and shall then be opened in the presence of such scrutineers as choose to be present, and counted in the manner, with such modifications as may be necessary, as is prescribed by section 79 of the Act for the counting of ordinary votes.

**21. Parcels to be forwarded to Registrar of Supreme Court** - After the votes have been recorded at the official count and after any recount has been disposed of, the Chief Returning Officer shall forward to the Registrar of the Supreme Court, with the ordinary and special ballot papers, the parcels referred to in regulation 19 of these regulations.

**22. Voting at hospitals** - (1) Where any hospital is appointed a polling place the Chief Returning Officer shall in addition to providing fixed booths in that hospital, appoint one or more Deputy Returning Officers to conduct the poll in any or all wards or rooms of that hospital and shall appoint one or more poll clerks to assist each such deputy returning officer, and the polling booth under the direction of any such Deputy Returning officer shall be known as a ward booth.

(2) If, during the course of polling, it appears to the Chief Returning Officer that there are insufficient ward booths in any hospital to satisfy the requirements of this regulation, he may provide additional ward booths in that Hospital, and may instead of appointing an additional Deputy Returning Officer and poll clerk for that purpose direct a that a fixed booth shall be converted to a ward booth.

(3) If and so long as a Deputy Returning Officer with a poll clerk is present in any ward or room in a hospital for the purpose of conducting the poll, that ward or room shall constitute the ward booth under the direction of that Deputy Returning officer.

(4) It shall be the duty of every Deputy Returning Officer having the direction of a ward booth to conduct that booth from time to time in each of the wards or rooms of that Hospital as may be appointed to him by the Chief Returning Officer.

(5) It shall not be necessary for a Deputy Returning Officer having the direction of a ward booth to remain constantly in any one ward or room during the whole of the hours of polling day but he shall with his poll clerk spend sufficient time or periods of time in each ward or room appointed to him to ensure that every bed patient who is for the time being confined to bed in that ward or room has a reasonable opportunity to cast his vote.

(6) While a bed patient is exercising his vote a screen shall be drawn or placed around his bed in such a manner as to constitute an inner compartment for the purposes of voting and such screen shall remain in place until such time as the voter signifies that he has marked his paper and folded it so that its contents cannot be seen.

(7) It shall be the duty of every Deputy Returning Officer having the conduct of the poll at a ward booth to enquire at reasonable intervals throughout the hours of polling to ascertain whether any electors or voters who have not already voted are bed patients in the wards or rooms appointed to him.

(8) An enquiry of the ward charge nurse or other person apparently having control or supervision of any ward or room shall be sufficient enquiry for the purposes of subclause (7) of this regulation in respect of that ward or room.

**23. Regulations to apply to By-elections** - These regulations shall apply with any necessary modifications to every By-election.
