SIMPLE OFFENCE

Punishment

> unless otherwise indicated

- ➢ fine not exceeding \$5,000
- > imprisonment for term not exceeding 5 years
- > loss of right to act as election officer

SIMPLE OFFENCE

Example

Failure of chief agent of political party to transmit return (maximum fine of \$25,000)

Punishment

>unless otherwise indicated:

- > fine not exceeding \$5,000
- > imprisonment for term not exceeding 5 years
- Ioss of right to act as election officer

Loss of right

➤ to be elected

> to sit in House of Commons

Loss of right

➤ to vote in election

> to hold any Cabinet-appointed office for 5 years

Example

> candidate who exceeds maximum authorized election expenses



CORRUPT PRACTICE

Punishment

identical to punishment for illegal practice ineligible for 7 years

CORRUPT PRACTICE

Example

party that incurs expenses to promote election of particular candidate other than the leader of party
