IN EXERCISE of the powers conferred by  
section 3 of the Local Government (District Councils  
Act, I, RICHARD ALLEN BANDA, Minister of Local  
Government, hereby make the following Order -

Citation

1. This Order may be cited as the Local Govern-  
ment (District Councils)(Blantyre District Council)  
(Amendment) Order, 1975.

2. Paragraph 8 of the Local Government (District  
Councils)(Blantyre District Council) Order is hereby  
amended by adding at the end thereof the following  
two new sub-paragraphs -

"(11) If the Minister is satisfied that any  
person selected as a nominated candidate  
from any Area is not eligible under sub-  
paragraph (4) for such selection, or had  
not been proposed, seconded or supported  
for such selection in compliance with  
the provisions of sub-paragraphs (5)  
and (6), he shall delete the name of  
such person from the list submitted to  
him pursuant to sub-paragraph (10), and  
may, in his discretion, select as a  
nominated candidate, in the place of

such person, a person who is so eligible for such selection, and, in such event, shall substitute, in the said list, the name of the person so selected by him for the name of the person so delete

- (12) If the public meeting of the residents of any Area, provided for by this paragraph, has not been held on the date fixed therefor pursuant to paragraph 7, or if, the said meeting having been held, no nominated candidate from such Area was selected thereat, the Minister, upon giving to the Regional Committee three days notice in writing of his intention so to do, may select not less than three nor more than five persons, who are eligible for such selection under sub-paragraph (4), as the nominated candidates from such Area and a copy of the list of such candidates so selected and certified by the Minister, shall constitute the certified copy list of nominated candidates from such Area for the purposes of paragraph 9 hereof."

1. This Order may be cited as the Local  
Government (District Councils) (Blantyre District  
(Council) (Amendment) Order, 1980.

2. Paragraph 3(4) of the Local Government  
(District Councils) (Blantyre District Council)  
Order is amended by adding thereto the following  
paragraph -

"(c) he satisfies the Minister that he is  
in possession of, or has at any time  
obtained, a Primary School Leaving  
Certificate or such other Certificate  
as the Minister, on the advice of the  
Minister of Education, considers to be  
equivalent of a Primary School Leaving  
Certificate;

Provided that where a person  
wishing to be selected as a nominated  
candidate does not hold the minimum  
educational qualification prescribed  
above, such person may, if the Minister  
so directs, be required to take and  
pass such oral and written proficiency  
examination as the Minister may approve,  
and such examination shall be prepared  
and conducted by a panel of examiners
