IFES is seeking one or two vendors for two separate projects. Bidders can submit one proposal with responses to both projects. However, the evaluation committee will evaluate each component separately. If one vendor is selected for both projects, separate contracts will be awarded for each project (to compliantly manage different sources of funds).

<u>Evaluation Criteria for Attachment A-Original content creation for video library and "About IFES"</u> video

IFES will evaluate bids based on the following criteria:

1. TIMELINE 25 points

- The vendor submits a clear timeline for the production and revision process
- The vendor submits a clear timeline for meeting the deliverables
- The vendor provides good ideas and recommendations on the sequencing of deliverables, including in the context of the second Project (see Attachment B)

2. EXPERIENCE 15 points

The vendor should demonstrate the following:

- Experience working with VIPs, including dignitaries, members of Congress, celebrities, etc.
- Examples of collaboration with overseas film crews/obtaining footage abroad
- Qualification of the team members (e.g., CVs)

30 points

The vendor should demonstrate the following:

- Creative ideas to build a video library to tell IFES' story in a cost-effective and compelling way
- Creative ways to leverage the video library and existing footage provided by IFES to produce a forward-looking, 3-to-4-minute video celebrating IFES' impact and future potential per the video specifications
- Ability to conduct up to 20 interviews, including in the Washington, D.C. area
- Strong proposals for efficient, cost-effective and creative ways to incorporate international footage into the video library and About IFES video per the SOW.

- Ability to secure its own production facilities and equipment to produce the videos, including but not limited to shooting, voicing, lighting, graphics, animation, editing, and music
- Ability to be responsible for all project management, leading the work and achieving project goals given scope, time and budget

4. PRICE 30 points

3. TECHNICAL APPROACH & QUALITY

20 points

The vendor should demonstrate the following:

- The quality of proposed work will ensure footage reflects the priorities of IFES Strategic Plan (2020-24), with emphasis on Strategic Objectives 2 4
- Ability to adhere to IFES' Do No Harm and accessibility principles
- Ability to create a short, inspirational and uplifting video for IFES to show at its Democracy Awards and 35th Anniversary Celebration on June 14, 2022 at the Four Seasons in Washington, D.C.
- Ability to use footage obtained from the first Project (see Attachment A) to create a video that celebrates IFES' 35th Anniversary ("35th Anniversary video").
- Ability to secure its own production facilities and equipment to produce the videos, including but not limited to shooting, voicing, lighting, graphics, animation, editing, and music.
- Ability to be responsible for all project management, leading the work and achieving project goals given scope, time and budget.
- Creative, cost-effective ideas to deliver a high-quality product per the video specifications and suggestions about similarities/differences between the two projects (Attachment A and B).

4. PRICE 30 points

3.6 Selection and Notification

IFES will evaluate Responses to identify responsible vendors and responsive offers. Finalists will be selected to move into the negotiation phase of this process. Written notification will be sent to finalists via email.

4 SCOPE OF WORK/GOODS/SERVICES

IFES is seeking one or two vendors for two separate projects. Bidders can submit one proposal with responses to both projects. However, the evaluation committee will evaluate each component separately. If one vendor is selected for both projects, separate contracts will be awarded for each project (to compliantly manage different sources of funds).

5 FUNCTIONAL REQUIREMENTS

5.1 Timeline

Prospective vendors must submit a timeline in the Response showing the time required to produce and consolidate the products and/or deliver services.

5.2 License, Clearance and Approvals

The prospective vendors will include in the timeline any time needed to obtain any licenses, clearances, and/or approvals required under local legal requirements to produce or deliver the products and/or services described in the Scope of Work.

5.3 Packing

The Response must contain details of packing for each product that requires shipping with full dimensions (length, width, and height) and weight.

6 QUALIFICATIONS & REFERENCES

Prospective vendors must provide the following information for their Response to be considered:

- 1. A brief outline of the company and services offered, including:
 - Full legal name and address of the company
 - Corporate and tax registration documents
 - Year business was started or established
 - Full name of the legal representative (president or managing director) of the company
 - Name of any individuals or entities that own 50% of more of the company
 - U.S. companies must indicate if they are a registered Small Business (Woman owned, veteranowned, Minority-owned, Disabled, Service Disabled Veteran-owned)
- 2. Evidence of successful completion of a project of a similar size and complexity.

- 3. References: Contact information for no less than three references from projects similar in size, application, and scope and a brief description of their implementation (including location and year). IFES reserves the right to request and check additional references.
- 4. Prospective vendors must be legally registered under the laws of the country in which they are organized and possess all licenses, permits and government approvals necessary for performance of the work. Scope of Work.
- 5. A certification signed by an officer or authorized representative that the prospective contractor/vendor has sufficient financial, technical and managerial resources and facilities to complete the Scope of Work.

7 PRICING

Prospective vendors must complete the following cost breakdown for the implementation of their solution for IFES' project as described in this solicitation. Prospective vendors must agree to keep these prices valid for a minimum of 90 calendar days.

Pricing must be in US Dollars (USD). Unit prices are required and in the case of discrepancies between unit prices and the total price, the unit price will be taken as reference basis in the evaluation. Technical specifications must be shown for each item. Value-added tax (VAT) and other applicable taxes should be listed separately.

Please submit separate financial proposals for each project.

IFES will use this video library to tell IFES' story — as well as that of our partners and beneficiaries — in diverse and compelling ways; better convey knowledge and learning; and expand and amplify our thought leadership among global influencers and policymakers.

Utilizing the new, original footage generated by this project – as well as existing footage/images found on IFES' YouTube channel and Flickr account, and/or otherwise provided by IFES – the vendor will also produce a forward-looking, 3-to-4-minute video celebrating IFES' impact and future potential. This video will be used as an evergreen introduction to IFES ("About IFES video").

IFES is open to creative, cost-effective ideas and suggestions about similarities/differences between the About IFES and 35th Anniversary video.

Goals:

- · Inspire and uplift gala attendees
- Inspire governmental and nongovernmental donors
- Briefly acknowledge IFES' founding and history, and educate about IFES' evolution into a multifaceted, global organization
- Grow general awareness about IFES' vision and mission, and elevate IFES' work under its <u>Strategic</u> Plan (2020-24), with emphasis on Strategic Objectives 2 4
- The target audiences for 35th Anniversary video include:
 - The 35th Anniversary Video will debut at a June 14 prestige gala in Washington, D.C., with members of Congress, the Biden Administration and other leaders, experts and advocates for democracy, human rights and governance in attendance
 - Social media followers after gala
 - Visitors to the IFES website

- Review/editing of script drafted by IFES
- Storyboards, as appropriate
- First draft video rough cut (IFES reserves the right to make at least two rounds of edits before the final video products are approved)
- Delivery of the final video in all required versions and formats (see "video specifications," above) by June 10, 2022 for use at IFES' 35th anniversary gala takes place on June 14, 2022

The vendor must secure its own production facilities and equipment to produce the videos, including but not limited to shooting, voicing, lighting, graphics, animation, editing, and music. The vendor is responsible for all project management, leading the work and achieving project goals given scope, time and budget.

The vendor's proposal should include:

- A proposed timeline of key activities and deliverables
 - \circ $\,$ IFES is open to vendor ideas and recommendations on sequencing/timelines in the context of Project 1
- Examples/samples of past projects, preferably of similar size and scope
- Examples of collaboration with overseas film crews/obtaining footage abroad
- Experience working with VIPs, including dignitaries, members of Congress, celebrities, etc.
- Team members and their qualifications
- Vendor production and revision process, with a proposed timeline
- Pricing details in the provided budget template, including cost-per-hour of revisions, labor, captioning, etc.
- Plan to ensure the video reflects the priorities of <u>IFES' Strategic Plan (2020-24)</u>, with emphasis on Strategic Objectives 2 4
- Ability to adhere to IFES' Do No Harm and accessibility principles
- Creative ideas to deliver a high-quality product in an efficient and cost-effective way
- Summary of any relevant experience and production resources demonstrating your ability to meet the requirements stated above
