In relation to the conduct of factual verification of election participants from political parties as regulated in KPU Decree Number 615 of 2003, I hereby reconfirm to you the following matters:

- 1. Political parties that have already registered and have been declared by the KPU to have fulfilled the administrative requirements shall be immediately and progressively advised to Provincial KPUs, so that Provincial KPUs can conduct the factual verification;
- 2. Political Parties' leaders at the provincial level, as referred to in Article 9 paragraph 2 of the KPU Decree Number 615 of 2003, shall submit the following required documents:
 - a. Decision of the head of the central leadership of the political party on the certification of the provincial administrators' formation of the political party;
 - b. Notification from the Head of Kecamatan about the permanent office address, with the relevant certified document attached to the notification letter;
- 3. The Provincial KPU shall only conduct factual verification in relation to political parties which have been declared to have fulfilled the administrative requirements by the KPU as mentioned in paragraph 1 above.
- 4. The factual verification to be conducted by the Provincial KPUs shall cover investigation of the correctness of:
 - a. The complete list of administrators of the political party, based on the decision of the head of the central leadership of the political party, in the relevant province;
 - b. Notification Letter about the permanent office addresses.
- 5. If any discrepancy is found in the information about the provincial leadership of the political party between the data submitted by the provincial leader of the

political party and the data submitted by the central leader of the political party, the data that shall be used shall be the data submitted or approved by the central leader of the political party.

- 6. The political parties declared not to have passed the factual requirements in the relevant province as referred to in Article 18 paragraph 3 of KPU Decree Number 615 of 2003, shall be advised by the Provincial KPU to Regency/City KPUs, cc'd to the KPU, so that factual verification shall not be continued by the Regency/City KPUs in the relevant province.
- The regency/city leaders of the political party shall submit the following required documents, as referred to in Article 9 paragraph 3 of KPU Decree Number 615 of 2003, to the Regency/City KPU:
 - Decision of the head of the central leadership of the political party on the certification of the regency/city administrators' formation of the political party;
 - b. Statement declaring that the political party has membership of at least 1000 people, or 1/1000th of the total population of the relevant regency/city, signed by the regency/city leader of the political party, which shall be supported by copies of valid political party membership cards;
 - c. Notification from the Head of Kecamatan about the permanent office address with related certified document attached to the notification letter;
- 8. If any discrepancy is found in the information about the regency/city leadership of the political party between the data submitted by the regency/city leader of the political party and the data submitted by the central leader of the political party, the data that shall be used shall be the data submitted or approved by the central leader of the political party.
- 9. The due date for submission of documents by political parties to provincial KPUs and regency/city KPUs is 16 October 2003.
